Your Worship and Councillors:

The Community Services Committee presents Report No. 2017-15 and recommends:

"That Council

- 1) authorize staff to continue to investigate options to replace West Ferris Arena, including initiating preliminary geotechnical assessments, to a maximum of \$60,000.00, of Memorial Gardens/Thomson Fields and Omischl Sports Complex or other viable sites, to determine the potential opportunity and challenges with respect to construction on those sites including potential site preparation costs; and
- 2) establish a Special Arena Committee made up of the Chair and Vice-Chair of the Community Services Committee plus a member from General Government and a member from the Engineering, Environment Services and Works Committees to lead a directed public consultation process, facilitate timely information sharing to Council and the Public of progress, and investigate financial options for the selection of ice pad and site options and funding alternatives to be pressented to Council as recommendations for the direction by October 31, 2017. The Committee shall report to Council as may be necessary at key decision points. In addition, the Committee shall be supported the Chief Administration Officer, the Managing Director of Community Services and the Chief Financial Officer of the City. The Mayor is an Ex-Officio Member."
