BY-LAW NO. 2003-176

**BEING A BY-LAW TO AMEND TRAFFIC & PARKING BY-LAW NO. 2002-001
SECTION 24 (NO PARKING AREAS) AND
SCHEDULE 20 (NO PARKING AREAS RESTRICTED TIMES)**

WHEREAS the *Municipal Act, 2001*, (S.O. 2001, c.25) authorizes the Council to pass By-laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

AND WHEREAS the *Highway Traffic Act*, R.S.O. 1990, Chapter H-8, as amended, authorizes the Council to pass By-laws regulating traffic on highways;

AND WHEREAS the amendments to Section 24 (No Parking Areas) and Schedule 21, Zone 4 (Parking Meter Zone 8 Hour) were authorized by General Government Committee Report No. 2003-26, as amended, passed by Council at its Regular Meeting held on Monday, November 3, 2003.

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Section 24 (No Parking Areas) to Traffic & Parking By-law No. 2002-001 is hereby amended by adding the following:

"ENTRANCE/
DRIVEWAY (21) within one (1) metre of an entrance/driveway."

2. That Schedule 20 to Traffic & Parking By-law No. 2002-001 is hereby amended by adding the following:

<u>"ROAD</u>	<u>SIDE</u>	<u>BETWEEN</u>	<u>PERIOD OF TIME</u>
11. First Avenue East	north	Ferguson and Fisher Streets	2 hours during 8:00 a.m. to 4:00 p.m., Monday to Friday inclusive
12. Second Avenue East	south	Ferguson and Sherbrooke Streets	2 hours during 8:00 a.m. to 4:00 p.m., Monday to Friday inclusive
13. Second Avenue East	both	Sherbrooke and Fisher Streets	2 hours during 8:00 a.m. to 4:00 p.m., Monday to Friday inclusive."

3. That this by-law comes into effect upon being passed.

READ A FIRST TIME IN OPEN COUNCIL THIS 15TH DAY OF DECEMBER, 2003.

READ A SECOND TIME IN OPEN COUNCIL THIS 15TH DAY OF DECEMBER, 2003.

READ A THIRD TIME IN OPEN COUNCIL AND ENACTED AND PASSED THIS 15TH DAY OF DECEMBER, 2003.
