BEING A BY-LAW to amend BY-LAW No. 858 by adding Schedule "C" thereto.

WHEREAS By-Law 858 is incomplete because of the omission of Schedule "C" to said By-Law.

THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:-

- 1. That By-Law No.858 is hereby amended by the addition of Schedule "C" hereto attached.
- 2. That recital paragraph No.2 in said By-Law No.858 be amended in the third last line by adding after the capital "B" the abbreviation and Capital "&C".
- 3. This By-Law shall take effect on the date of the passing thereof.
