BY-LAW NO. 1202

BEING A BY-LAW to license residents owning and using Bicycles on the Highway.

THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY
OF NORTH BAY ENACTS AS FOLLOWS:-

- l. No person resident in the City of North Bay owning or using a Bicycle shall use the same upon any highway of the City unless and until he shall obtain a license therefor and every person so licensed shall be subject to the provisions of this By-Law.
- 2. Every applicant for such a license shall be made to the Chief Constable or his Deputy, where all particulars of said Bicycle, sufficient for identification purposes, will be registered in a book kept for that purpose. And that before a registered bicycle can be disposed of, the owner shall have same transferred to new owner.
- 3. Every such license shall be executed on behalf of the Corporation by the Chief Constable who is hereby authorized to execute and issue same and shall be made out in duplicate and one of such duplicates shall be delivered to the person licensed and the other shall be retained and kept on file by the Chief Constable.
- 4. Every person licensed under this By-Law shall produce his license whenever it may be demanded by the Chief Constable or any Justice of the Peace or Police Constable authorized to demand its production.
- 5. Each license issued under the provisions of this By-Law shall be an annual license and shall expire on the 20th. day of January following the date from which the license takes effect.
- 6. The annual fee for each such license shall be TWENTY-FIVE CENTS (25ϕ) which shall be paid to the Treasurer by the person obtaining the license at the time license is issued.
- 7. Every person guilty of a breach of any provision of this By-Law shall forfeit and pay at the discretion of the convicting magistrate a penalty not exceeding (exclusive of costs) the sum of Five Dollars (\$5.00) for each offence which penalty may be recoverable in the manner provided by the Municipal Act.

8. This By-Law shall go into effect immediately upon the passing thereof.
