BEING A BY-LAW TO AMEND BY-LAW NO. 55-68, A BY-LAW TO PROVIDE THE SUM OF \$43,075.00 FOR THE COMMUNITY MEMORIAL BUILDING COMMISSION OF THE CITY OF NORTH BAY TO DEFRAY THE COST OF PERMANENT IMPROVEMENT AND EQUIPMENT.

WHEREAS the Council of the Corporation of the City of North Bay deems it expedient to increase the sum to be provided for the Community Memorial Building Commission of the City of North Bay, to defray the cost of Permanent Improvement and Equipment.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. That Clause (1) of By-law No. 55-68 be amended to increase the sum to be provided by \$25,200.00 so that it shall now read as follows:
 - "That capital funds in the sum of \$68,275.00 be provided for the Community Memorial Building Commission of the City of North Bay, for permanent improvements and equipment for Memorial Gardens Sports Arena in the City of North Bay and West Ferris Community Centre in the City of North Bay, and more particularly set forth and described in Schedule "A" to this By-law."
- 2. That Schedule "A" of By-law No. 55-68 be amended to read in accordance with Schedule "A" attached hereto and forming part of this By-law.
- 3. This By-law shall not become effective until approval, in writing, has been secured from the Ontario Municipal Board pursuant to Section 64(1) of The Ontario Municipal Board Act, R.S.O. 1960, Ch. 274.
