BY-LAW NO. 406

BEING A BY-LAW AUTHORIZING THE MUNICIPAL COUNCIL OF THE TOWN OF NORTH BAY TO CLOSE A LANE ON THE SOUTH SIDE OF MAIN STREET IN THE SAID TOWN.

WHEREAS an agreement has been made between the Municipal Corporation of the town of North Bay, of the one part, and H. W. Angus and L. W. Henderson of the said town, of the other part, for the exchange of certain property.

AND WHEREAS a transfer has been executed by the said H. W. Angus and L. W. Henderson in favor of the Corporation of the said town, covering the property which the said parties have agreed to convey to the said town, namely: Part of Lot number Eighty one (81) on the south side of Main Street having a fromage of sixteen feet nine inches (16.9") by a uniform depth of one hundred and ten feet (110.) as shown on plan of part of the said town prepared by J. L. Morris and registered in the Registry Office for the District of Nipissing on the 15th day of September 1898.

AND WHEREAS in consideration of receiving the transfer of the said property from the said Angus and Henderson, the Municipal Corporation of the said town of North Bay have agreed to convey to the said H. W. Angus the following lands and premises, namely - a lane sixteen feet nine inches (16.9") wide and one hundred and ten feet (110.) long in the said town of North Bay situate between lots numbers twenty three and eighty three on the south side of Main Street in the said town according to a plan of a portion of the said town prepared by DeMorest Stull & Lowe and registered in the Registry Office for the District of Nipissing on the 13th day of November 1909.

AND WHEREAS all the steps required by the Municipal Act in connection with the closing of lanes, have been complied with, and no person has made application to the Council objecting to the closing of the said lane.

BE IT ENACTED AND IT IS THEREFORE HEREBY ENACTED BY THE MUNICIPAL COUNCIL OF THE TOWN OF NORTH BAY AS FOLLOWS:

1. THAT the property hereinafter described, namely - a lane sixteen feet nine inches (16.9") wide and one hundred and ten feet (110.) long situate between lots numbers Twenty three (23) and Eighty three (83) on the south side of Main Street in the said town of North Bay, according to a plan of a portion of the said town prepared by DeMorest Stull & Lowe and registered in the Registry Office for the District of Nipissing on the 13th day of November 1909, be closed, and that a conveyance of the said property signed by the proper authorities of the said town, be executed, transferring the said property to the said H. W. Angus.

This Bylaw shall take effect immediately after the passing thereof.
