Your Worship and Councillors:

The General Government Committee presents Report No. 2010-02 and recommends:

- 1. That the 2010 Operating Budget in the amount of \$105,345,783 (save and except the Humane Society budget of \$300,700 and the District of Nipissing Social Services Administration Board levy of \$13,814,901) with a resultant tax levy of \$68,457,603 as summarized on the attached **Schedule A**, be approved.
- That the Water and Sanitary Sewer Operating Budget in the amount of \$17,123,500 as summarized on the attached **Schedule B** be approved.
- 3. That budget adjustments summarized on the attached **Schedule C**, resulting in a net reduction in the tax levy totaling \$581,300 from the Preliminary Operating Budget, be included in the Operating Budget.
- 4. That the 2010 real growth in the assessment base be applied to reduce 2010 tax rates by a further 0.89%, or \$584,000.
- 5. That the Chief Financial Officer be authorized to process all transfers to and from reserve funds included in the 2010 Operating Budget, including a transfer of \$680,000 from the Tax Rate Stabilization Reserve Fund.
- 6. That the levies of all Agencies, Boards and Commissions totaling \$35,211,586 as summarized on the attached **Schedule D** be included in the tax levy.
- 7. That the Chief Financial Officer be authorized to transfer \$7,433,000 from the Operating Fund to the Capital Fund to finance approved capital projects that would otherwise require debenture issuance to fund (Net Capital Levy in Operating Budget). This is often referred to as the "Pay As You Go" funding for capital projects.

- 8. That the tax policy recommendations outlined in Report to Council CORP 2010-11 be adopted as follows:
 - a) That the 2010 tax ratios remain at the 2009 levels as follows:

Multi-Residential - 2.2054
Commercial - 1.8822
Industrial - 1.4000
Pipeline - 1.1656
Farmland - 0.1500
Managed Forest - 0.2500

- b) Council decisions to reduce tax ratios will be made at the onset of a reassessment year once the four-year tax shifts are known. Council's decisions to reduce the tax ratios will be considered for the four year cycle commencing with the 2013 reassessment year.
- c) <u>Definition of "Real Assessment Growth"</u>

Real Assessment Growth means new assessment which is generated by supplementary assessment roll(s) resulting from an increase in value of properties for: new buildings or structures, alterations/additions to buildings or structures and new lots created by subdivision/condominium plans and severances; and netted by assessment reductions resulting from assessment appeals under Section 39.1(1.1) of the *Assessment Act* (supplementary assessments).

- d) That excess supplementary commercial and multi-residential municipal taxes totaling \$65,000 be transferred to the Tax Policy Development Reserve Fund as at December 31, 2009.
- e) That the Manager of Revenues and Taxation file a Report to Council outlining options and recommendations for the 2010 Capping Program.
- 9. The Reserve Fund Policy be amended and the implementation targets updated as follows:
 - a) Authority to Transfer Funds to Reserve Funds section of policy be amended to include requirement for Chief Financial Officer to prepare a Report to Council recommending transfer of any one-time non sustainable revenue received to a reserve fund.
 - b) Target level for Capital Budget Contingency Reserves should be reduced from 50% to 40% of the Capital Funding Policy Expenditure Limits (Both Tax Levy and Water Levy).
 - c) The target level for discretionary reserve funds should total at least between a level equal to 30% of the total municipal tax levy plus the water bill revenues and \$500 per capita.
 - d) That the Chief Financial Officer be authorized to process the following year-end transfers to reserve funds as at December 31, 2009:
 - i) That the year-end budget surplus (or deficit) be transferred to (from) the Tax Rate Stabilization Reserve Fund.
 - ii) That the year-end Police surplus estimated to be \$90,000 be transferred to the Police Vested Sick Leave Reserve Fund.
 - iii) That an additional \$400,000 be transferred from the Police Services Reserve Fund to the Police Vested Sick Leave Reserve Fund.

- 10. a) The Ten-Year Capital Forecast (2010-2019) for Capital Projects to be funded from Debentures, Capital Levy, Development Charges, Federal and Provincial Government Grants Programs, Reserves and other contributions totaling \$331,685,000 as set out in Report to Council CORP 2009-193 be adopted.
 - b) The Ten-Year Capital Forecast (2010-2019) for Capital Projects to be funded from Water and Sanitary Sewer Rates, Debentures, Development Charges, Federal and Provincial Government Grants Programs, Reserves and other contributions totaling \$161,172,000 as set out in Report to Council CORP 2009-193 be adopted.
 - c) That the Tax Levy Supported Long Term Capital Funding Policy be amended as follows:
 - i) Based on the 2008 estimate of the need to increase the annual investment in infrastructure by \$20 million to reach a sustainable investment level.
 - ii) Debt levels need to be controlled but not eliminated in the 20 year framework of the policy.
 - iii) Debt service costs (principal and interest payments) as a percentage of total tax levy will not exceed 15%.
 - iv) "Pay as you go" capital revenue will be targeted at levels equal to or greater than "long term debt" capital revenues.
 - v) Long Term Capital Funding Allocation in the Operating Budget be increased by an inflationary allowance plus1% of the tax levy each year instead of the \$600,000 in the current policy.
 - vi) The annual debenture funding be increased from \$6,200,000 in 2009 to \$8,000,000 in 2010 and be increased each year by \$500,000 until it reaches a level of \$13,000,000 in 2020.
 - vii) The Capital Expenditure Limits be set based on the capital revenue sources generated by the policy.
 - viii) That the Long Term Capital Funding Policy be reviewed each year to ensure that the sustainable target levels are reasonable and that it is adjusted based on the impact of new alternative revenues sources and sustainable revenue sources from the Federal and Provincial governments.
 - d) That the Water Levy Supported Long Term Capital Funding Policy be amended as follows:
 - i) Long Term Capital Funding allowance in the Water and Sanitary Sewer Operating Budget be increased by an inflationary allowance plus 2% of the water bill revenues each year instead of the \$300,000 in the current policy
 - ii) The annual debenture funding be set at \$2,000,000 in 2010 and increased each year by \$500,000 until it reaches a level of \$3,000,000 in 2012
 - iii) The Capital Expenditure Limits be set based on the capital revenue sources generated by the policy
 - iv) That the Long Term Capital Funding Policy be reviewed each year to ensure that the sustainable target levels are reasonable and that it is adjusted based on the impact of new alternative revenues sources and sustainable revenue sources from the Federal and Provincial governments.

- 11. That the tax rates included on **Schedule E** be adopted for the 2010 taxation year.
- 12. That each final tax bill clearly discloses the amount included to subsidize provincial health and social programs as described by the Association of Municipalities of Ontario as "Ontario's \$3 Billion Provincial Municipal Fiscal Gap".
- 13. That the due date for the final property tax installment be set at June 30 for the 2010 taxation year.
- 14. That the by-laws arising from this report be presented for three (3) readings on March 8, 2010.
- 15. That the Chief Financial Officer prepare and submit a Comprehensive Long Term Financial Plan for City Council's consideration by April 30, 2010.
- 16. Should the 2010 Provincial Budget address our request for additional Ontario Municipal Partnership Fund grants for northern municipalities, or provide any financial benefits that have not been accounted for in the 2010 City of North Bay Operating Budget, we will re-open our 2010 budget and pass every dollar received back to the taxpayers of the City of North Bay.
