The Community Services Committee presents Report No. 2003-11 and recommends:

- 1. That the presentation by Don Priebe on January 22, 2001 relating to a Sports and Leisure Complex be noted and file.
- 2. That a) the application by M. & L. Poulin on behalf of I. & A. Boaro to rezone the northwesterly 0.2 hectares of Parcel 3995 from a "Residential Holding (RH)" zone to a "Neighbourhood Commercial Special (C5 Sp.)" zone and the northeasterly 0.2 hectares from a "Neighbourhood Commercial Special No. 35 (C5 Sp. 35) zone to a "Residential Holding (RH)" zone be denied;
