BY-LAW NO. 80-94

BEING A BY-LAW TO TEMPORARILY CLOSE PORTIONS OF STREETS IN THE CITY OF NORTH BAY

WHEREAS pursuant to the request of the North Bay Gateway Heritage Festival Committee, it is deemed expedient to temporarily close portions of Memorial Drive, Beth Avenue, Colgan Avenue, James Avenue, Queen Street and Oak Street, pursuant to the Municipal Act, R.S.O. 1990, Chapter M-45, Section 207, Subsection 44.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

- 1. That a portion of Memorial Drive from Judge Avenue to the C.P.R. tracks, Beth Avenue at the Memorial Drive intersection, Colgan Avenue at the Memorial Drive intersection, James Avenue at the Memorial Drive intersection, and Queen Street at the Memorial Drive intersection be and the same are hereby closed from 6:00 o'clock in the afternoon of Friday, July 29, 1994, until 11:59 in the afternoon of Monday August 1, 1994, for the purpose of a Heritage Festival.
- 2. That the portion of Oak Street from John Street to Main Street (overpass) be and the same is hereby closed Saturday July 30, 1994, from 10:00 o'clock in the forenoon until 7:00 o'clock in the afternoon and on Sunday July 31, 1994, from 10:00 o'clock in the forenoon until 7:00 o'clock in the afternoon for the purpose of a Heritage Festival.
- 3. That the Director of Transportation and Works is hereby authorized to have barricades and warning devices erected to carry out the said closure.
- 4. That prior to 1:00 o'clock in the forenoon on the 2nd day of August 1994, the Director of Transportation and Works will attend to the restoration of the said portions of Memorial Drive, Beth Avenue, Colgan Avenue, James Street and Queen Street to their condition prior to the above closure.
- 5. That prior to 8:00 o'clock in the afternoon on July 30 and July 31, 1994, the Director of Transportation and Works will attend to the restoration of the said portion of Oak Street to its condition prior to the above closure.
- 6. That no person shall drive a vehicle at a greater speed that 15 km/hr on Memorial Drive between Judge Avenue and the C.P.R. tracks between 6:00 o'clock in the afternoon July 29, 1994, and 11:59 o'clock in the afternoon on August 1, 1994.
