

BY-LAW NO. 1234

BEING A BY-LAW to repeal By-Law No. 1193 and to provide for the payment of the Taxes of the Corporation of the City of North Bay in instalments.

WHEREAS it is deemed advisable to repeal By-Law No. 1193 and to pass a By-Law to provide for the payment of the Taxes of the Corporation of the City of North Bay in instalments.

BE IT ENACTED AND it is therefore hereby enacted that By-Law No. 1193 of the City of North Bay be, and the same is hereby repealed and the Municipal Council of the City of North Bay enacted as follows:

1. THAT the Current Year's Taxes appearing on the Collector's Roll opposite the name of each person or persons liable for the Taxes as shown on the said Roll shall be paid in SIX instalments.

2. The FIRST Instalment (25%) of such taxes shall be due and payable on the 15th. day of May in each year; the SECOND Instalment (15%) shall be due and payable on the 15th. day of June in each year; the THIRD Instalment (15%) shall be due and payable on the 15th. day of July in each year; the FOURTH Instalment (15%) shall be due and payable on the 15th. day of August, in each year; the FIFTH Instalment (15%) shall be due and payable on the 15th. day of September in each year; the SIXTH instalment (15%) shall be due and payable on the 15th. day of October in each year, and shall be collected as provided by Statute, provided that, if any of the above mentioned dates falls on a Sunday or legal holiday, then the payments are to be made on the following day.

3. THAT the last days of grace for payment of instalments of Taxes shall be; First Instalment - May 18th; Second Instalment June 18th; Third Instalment - July 18th; Fourth Instalment August 18th; Fifth Instalment - September 18th. and Sixth Instalment - October 19th.

4. UPON the failure to pay any instalment as it becomes due, the full amount of Taxes for the year, less any payments already made shall forthwith become due and payable, and shall be collected by the Collector according to law.

5. THAT an addition of 4% shall be added to the amount of the first instalment or any portion of it remaining unpaid after the 18th. day of May; a similar addition shall be made to the second instalment or any part thereof remaining unpaid after the 18th. day of June; a similar addition shall be made to the third instalment or any part thereof remaining unpaid after the 18th. day of July; a similar addition shall be made to the fourth instalment or any part thereof remaining unpaid after the 18th. day of August; a similar addition shall be made to the Fifth instalment or any part thereof remaining unpaid after the 18th. day of September; and a similar addition shall be made to the Sixth instalment or any part thereof remaining unpaid after the 19th. day of October; and it shall be the duty of the Collector of Taxes to collect by distress or otherwise all such taxes or instalments of taxes as remain unpaid together with the said percentage charges as aforesaid.

6. The Collector of Taxes is hereby authorized to accept any partial payment of said Taxes tendered or offered to him.

7. All arrears of Taxes shown on Current Year's Roll shall be payable with the First Instalment of Current Taxes and the statutory interest shall be added to the Arrears to date of payment.

8. THAT all taxes due the Municipality shall be paid to the Collector of Taxes and the said Collector is hereby authorized to receive said Taxes and immediately pay the same over to the Treasurer and take his receipt therefore.

9. THAT nothing herein contained shall be held or construed to do away with the right of the Collector to distrain for the whole amount of taxes on failure of payment of any of the instalments or any part of the same at any times mentioned above for the payment thereof.
