BY-LAW NO. 1481

A BY-LAW to provide for the 1947 Expenditure on Roads or Streets in the City of North Bay in the District of Nipissing.

WHEREAS the Highway Improvement Admendment Act 1947 requires that a By-Law to provide for expenditure on roads or streets be submitted annually to the Minister of Highways for approval, and

WHEREAS the assessment of this municipality on which the rates of general municipal taxation for the current year have been or are to be levied is \$10,292,470.

THEREFORE THE COUNCIL OF THE CORPORATION OF THE SAID CITY ENACTS AS FOLLOWS:

(1) The sum of \$44,780.00 is hereby appropriated from monies raised by levy, debentures and government subsidy for expenditure on construction and maintenance of the roads or streets in the said City during the year 1947 as follows:

- (3) The Clerk shall transmit <u>duplicate</u> copies of this By-Law to the Municipal Roads Branch, Department of Highways, for approval.
