AND WHEREAS the province has decreased its annual grants since 1985 from 15% of annual revenue to 4% of annual revenue which continues to threaten the future of these engines of cultural and economic development.

NOW THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the City of North Bay petitions that the Province increase its annual grants to 15% of library revenue.

AND FURTHER THAT a copy of the motion be forwarded to the Premier of Ontario, the Honourable Aileen Carroll Minister of Culture, the Honourable Monique Smith MPP for Nipissing, the Ontario Library Service, Association of Municipalities of Ontario, the Federation of Northern Ontario Municipalities, the Leaders of the Opposition and to the North Bay Public Library Board.
