BY-LAW NO. 1999-43

BEING A BY-LAW TO AUTHORIZE CONSTRUCTION OF A WATERMAIN AND APPURTENANCES AND TO IMPOSE AN IMMEDIATE BENEFIT AREA FRONTAGE WATER WORKS RATE ALONG GOLF CLUB ROAD IN THE CITY OF NORTH BAY

WHEREAS Council deems it desirable to impose a water works rate, pursuant to Section 221 of the Municipal Act, R.S.O. 1990, Chapter M-45, upon the owners of the lands who derive or will or may derive a benefit therefrom sufficient to pay approximately 33 1/3% of the cost of the works to construct approximately 1100 feet of 8" diameter watermain and appurtenances and 400 feet of 6" watermain and appurtenances along Golf Club Road;

AND WHEREAS notice of the intention to do this work was advertised in the newspaper and no one has applied to be heard before Council;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

I. In this By-law:

"Capital cost" means the cost of constructing waterworks, inclusive of all items of cost chargeable to the capital account, together with appurtenances and connections.

- 2.1 An annual waterworks rate is hereby imposed on the frontage of the immediate benefit area lands described in Schedule "A" for a period of ten years from the date certified by the Treasurer for the completion of the works, for the capital cost of the waterworks described on Schedule "A" hereto, save and except as to St. John's Cemetery.
- 2.2 St. John's Cemetery shall pay a flat rate of \$ 20,000.00 by lump sum within 60 days of the passing of this by-law in full satisfaction of its share of the capital cost of the waterworks constructed for the immediate benefit area on and about Golf Club Road.
- 3. The Corporation of the City of North Bay is hereby authorized to carry out the water works set out on Schedule "A" hereto annexed for not more than the estimated cost as set out in Schedule "A" as provided by plans and specifications furnished by the City Engineer.
- 4. The City Engineer of The Corporation shall make such plans, profiles and specifications and furnish such information as may be necessary for the making of a contract for the execution of the work.
- 5. The works shall be carried out and executed under the superintendence and according to the directions and orders of the Corporation's Engineers.
- 6. The Mayor and Clerk are hereby authorized to execute a contract for the construction of the work to be made and entered into with the approval of this Council.
- 7. The Mayor or Deputy Mayor and the Treasurer of the City of North bay are hereby authorized to borrow from time to time from any bank or person by way of promissory note or notes temporary advances of money to meet the cost of construction as aforesaid pending the completion thereof and pending the issue and sale of the debentures hereinafter referred to, but in no event shall the aggregate of such borrowings exceed the amount limited in this by-law.
- 8. The debentures to be issued for the loan to be effected to pay for the cost of the work when completed shall bear interest at such rate as Council shall determine and be made payable within ten (10) years on the instalment plan.

- 9. Any person whose lot is specially assessed hereunder may commute for a payment in cash the special rate imposed thereon by paying the "Total Cost" portion of the cost of construction assessed upon such lot by Schedule "A", without interest within 60 days after the assessment roll of the immediate benefit area has been certified by the Clerk.
- 10. After the debentures have been sold, any person whose lot is specially assessed may commute the balance of the special assessment by paying to the Corporation an amount which, when invested at the current interest rate certified by the City Treasurer will be sufficient to pay the unmatured annual debt charges of the special assessment.
- (1) The City Treasurer shall take all such steps as are necessary to impose the rates set out herein, to determine the applicable rates for each property, to create a Special Water Works Rate Collectors Roll therefor, and the decision of the City Treasurer shall be final and binding.
 - (2) The City Treasurer shall act in good faith and may make such adjustments as may be required having regard to what is just and equitable.
 - (3) The Tax Collector shall bill and collect such rates according to the instalment schedule of the levy for interim and final municipal taxes.
