Res. #2019-14:

Moved by Councillor Bain, seconded by Councillor Tignanell Whereas the Province of Ontario passed Bill 184, Endangered Species Act, 2007, with the purpose "To protect species that are at risk and their habitats, and to promote the recovery of species that are at risk";

And Whereas the City of North Bay "admires, values and respects the natural environment";

And Whereas the City of North Bay has a defined Urban Settlement Area and within that area there is a considerable amount of developable land that is impacted by the *Endangered Species Act*;

And Whereas the City of North Bay's Urban Settlement Area represents only 20% of the total land area within the boundaries of the City of North Bay;

And Whereas the remaining 80% of the land within the City of North Bay will continue to be protected under the *Endangered Species Act* and provide substantial habitat protection for species at risk;

And Whereas intensification of Urban Settlement Areas is recognized as a best practice planning principle and is encouraged under the Provincial Policy Statement;

And Whereas complying with the requirements of Bill 184 creates uncertainty with respect to the cost and timing of development;


And Whereas the Minister has the authority under Section 17(2)(d) of the *Endangered Species Act* to exclude certain lands from the requirements of the Act where the development provides for a significant social or economic benefit.


Therefore Be It Resolved that the City of North Bay ask the Province of Ontario to exclude all land, streams and lakes within the City of North Bay's Urban Settlement Area (as recognized on January 1, 2019), from the requirements of Bill 184.

And further that during the planning process the City of North Bay will consult with the Ministry of Natural Resources and the North Bay-Mattawa Conservation Authority.

And Further that a copy of this Resolution be forwarded to the Minister of the Environment, Conservation and Parks The Honourable Rod Phillips, the Minister of Finance The Honourable Victor Fedeli, the Leaders of the Opposition, The Association of Municipalities of Ontario and The Federation of Northern Ontario Municipalities.

The map below which shows the Urban Area (15,965.28 acres) and the total area of the City (79,462.05 acres). These calculations exclude lakes and rivers etc. The urban service boundary makes up 20.09% of the City.

Res. #2019-15: Moved by Councillor Bain, seconded by Councillor Mendicino Whereas the City of North Bay "admires, values and respects the natural environment";

And Whereas the Provincial Policy Statement in effect between 1997 and 2005 created flexibility by allowing development where it was demonstrated that there would be no negative impacts on the natural features or ecological functions of the area (including Provincially Significant Wetland);

And Whereas intensification of your Urban Settlement Area is recognized as a best practice planning principle;

And Whereas Section 2.1 of the Provincial Policy Statement, 2014, precludes development and site alteration within Provincially Significant Wetlands. As such, in considering any development applications, within or adjacent to a Provincially Significant Wetland, the approval authority is required to ensure that the Provincially Significant Wetland is appropriately protected from development;

And Whereas prior to 2005, the Council of the City of North Bay approved a successful approach to use two (2) acres of Provincially Significant Wetlands for development, by rehabilitating seven (7) acres of wetland downstream.

Therefore Be It Resolved that the City of North Bay ask the Province of Ontario to allow a municipality within its Urban Settlement Area (as recognized on January 1, 2019), to use Provincially Significant Wetlands for development where the applicant can demonstrate no negative impacts on the natural features or the ecological functions for which the area is identified.

And further that during the planning process the City of North Bay will consult with the Ministry of Natural Resources and the North Bay-Mattawa Conservation Authority.

And Further that a copy of this Resolution be forwarded to the Minister of the Environment, Conservation and Parks the Honourable Rod Phillips, the Minister of Finance the Honourable Victor Fedeli, the Leaders of the Opposition, The Association of Municipalities of Ontario; The Federation of Northern Ontario Municipalities.
