## **BY-LAW NO. 2006-69**

## BEING A BY-LAW TO AUTHORIZE THE 2006 CAPITAL ALLOCATION TO THE NORTH BAY-MATTAWA CONSERVATION AUTHORITY

WHEREAS the *Municipal Act*, 2001 (S.O. 2001, c-25), Section 326 authorizes the Council to pass a by-law for the purposes therein stated;

**AND WHEREAS** the *Municipal Act*, 2001 (S.O. 2001, c-25), Section 401 authorizes the Council to pass a by-law for the purposes herein stated;

**AND WHEREAS** the Council passed Resolution 2006-177 at its meeting held March 27, 2006, authorizing the 2006 capital allocation to the North Bay-Mattawa Conservation Authority of \$80,652.00;

## NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS;

 That the expenditure of \$80,652.00 for the following projects for the North Bay-Mattawa Conservation Authority be hereby authorized for:

Parks Creek Flood Control Structure \$ 12,500.00

Chippewa Creek between Hammond Street
And Second Avenue – CN Rail embankment 37,500.00

Central Workshop Repairs 30,652.00

Net Amount to be Debentured \$ 80,652.00

- 2. That the Treasurer of the City of North Bay is hereby authorized to borrow from time to time from any bank or person by way of promissory note or notes temporary advances of money to meet the cost of work as aforesaid pending the completion thereof and pending the issue and sale of the debentures hereinafter referred to but in no event shall the aggregate of such borrowings exceed the amount of \$80,652.00 limited in this by-law.
- 3. Any promissory note or notes issued pursuant to paragraph 2 hereof shall be sealed with the seal of The Corporation of the City of North Bay and signed by the Mayor or Deputy Mayor and the Treasurer of the City of North Bay.
- 4. That the debentures to be issued when the work is completed to pay for the cost of such work shall bear interest at such rate as the Council may determine and shall be made payable within fifteen (15) years.

READ A SECOND TIME IN OPEN COUNCIL THIS 10<sup>TH</sup> DAY OF APRIL, 2006.

READ A THIRD TIME IN OPEN COUNCIL AND ENACTED AND PASSED THIS 10<sup>TH</sup> DAY OF APRIL, 2006.
