

BEING A BY-LAW TO PROVIDE FOR THE APPOINTMENT OF
A POUND-KEEPER AND TO REGULATE THE POUND.

THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION
OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:-

1. THIS By-Law is enacted under the authority of Section Three Hundred and Ninety-Nine (399) of the Municipal Act and Chapter Two Hundred and Forty-Seven (247) of the Revised Statutes of Ontario, 1914, and entitled an Act respecting pounds.
2. NO PERSON shall suffer or permit any horse, bull, ox, cow, sheep, goat, pig or other cattle or geese or other poultry of which he is the owner, or of which he shall be in possession or in charge or keeping, to run at large or trespass within the limits of the City.
3. There shall be a Public Pound established in the City of North Bay.
4. The premises known as

Situatè on

Street to-gether with the outbuildings and enclosures appurtenant thereto are hereby set apart for and declared to be the Pound for the City of North Bay, and the Pound-Keeper thereof shall be Mr. George Hocey.
5. All horses, bulls, oxen, cows, sheep, goats, pigs or other cattle, and all geese or other poultry unlawfully running at large or trespassing or doing damage within the said City shall be empounded at the said Pound as hereinbefore mentioned, and delivered to the keeper thereof.

6. Every Pound-Keeper, before entering on the duties of his office shall give a Bond to the Corporation in the penal sum of One Hundred Dollars (\$100.00), together with two sufficient sureties of Fifty Dollars (\$50.00) each, conditioned that the said Pound-Keeper shall well and faithfully discharge the duties of his office, including all duties imposed on him by the said Revised Statutes of Ontario, Chapter Two Hundred and Forty-Seven (247).

7. The City Treasurer shall furnish the Pound-Keeper with a Book, in which the Pound-Keeper shall enter a description of every animal impounded by him, with the name of the person who took or sent same to be impounded, the day and hour on which the same was redeemed (if redeemed) and the amount of damage or penalty and fees paid by the party redeeming the same, or the proceeds of the sale (if any made) and the Pound-Keeper shall on or before the 15th day of January in every year, file with the City Clerk a certified statement for the year ending on the Thirty-first day of December, prior to that in which the statement is filed, showing:-

- (a) The Number of animals impounded or distrained, as the case may be.
- (b) The Number of animals sold and the amount of ~~money~~ received.
- (c) The sum received as poundage fees and cost of keep by the Pound-Keeper or party distraining.
- (d) The amount of damage paid by any party.
- (e) All disbursements and to whom paid.
- (f) Any other receipts and expenditures in connection therewith.

8. The Pound-Keeper shall at all times produce his book for the inspection of the City Clerk or of any member of the Council, upon request made to him for the purpose.

9. The Pound-Keeper shall be entitled to the following fees for impounding :-

- Every horse, bull, ox, sheep, goat ,pig, or other cattle.....\$ 1.00
- Every goose or other poultry.....\$.10

And shall also be entitled to the following charges:-
For providing food, water and shelter for animals :-

- Every horse.....1.00 cents per day.
- Every sheep,pig or goat.... .50 cents per day.
- Every bull,ox,cow,or other cattle..... .75 cents per day.
- Every goose or other poultry 05 cents per day.
- For posting notice of sale. .50 cents.
- For attending for the summons and serving the same on the appraisers of damages.75 cents.
- For every sale of distress....50 cents.


10. Any person convicted of a breach of any of the provisions of this By-Law shall forfeit and pay at the discretion of the convicting Magistrate, a penalty not exceeding (Exclusive of costs) the sum of Fifty Dollars (\$50.00) for each offence, and in default of payment of the said penalty and costs forthwith, the said penalty and costs or costs only, may be levied by distress and sale of the goods and chattels of the offender, and in case of there being no distress found out of which such penalty can be levied, the convicting Magistrate may commit the offender to the Common Gaol of the City of North Bay,with or without hard labour, for any period not exceeding six calender months, unless the said penalty and costs,(if any) including the costs of the said distress and of the committal and conveyance of the offender to the said Gaol, are sooner paid.

11. THAT By-Laws Numbers ⁵⁷⁸~~526~~ ; 691 and 712 A,
 and all other By-Laws inconsistent with this By-Law
 are hereby repealed.
