

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 124-71

BEING A BY-LAW AUTHORIZING THE SALE AND TRANSFER OF CERTAIN PROPERTY WITHIN THE CITY OF NORTH BAY TO KIRKWALL HOLDINGS LIMITED.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. The Corporation of the City of North Bay shall sell and transfer to Kirkwall Holdings Limited the lands and premises described in Schedule "A" attached hereto and forming part hereof for the sum of \$13,600.00.
- 2. The Mayor and Clerk are hereby authorized and empowered to execute on behalf of The Corporation of the City of North Bay a Transfer of the said lands to Kirkwall Holdings Limited, and to affix thereto the corporate seal.

SECONDLY:

Lots 641 and 642 on the west side of Princess Street in the City of North Bay, in the District of Nipissing, and registered in the Registry Office for the Registry Division of the District of Nipissing on a plan of McAuslan & Anderson O.L.S. registered the 16th day of June, 1913 as Plan 93.
