BEING A BY-LAW TO AMEND BY-LAW 35-68 BEING A BY-LAW FOR THE PURPOSE OF AMENDING BY-LAW NO. 1446 UNDER THE AUTHORITY OF SECTION 30 OF THE PLANNING ACT, R.S.O. 1960 AND AMEND-MENTS THERETO.

WHEREAS it is necessary to amend By-law 35-68 to allow a building over 35 feet on certain lots in the City of North Bay. NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

THAT paragraph 1 of By-law 35-68 be amended to read as follows:

1. THAT Section 7, Sub-section 3(c) shall be amended by adding thereto after the words 35 feet, the words "except on the property described as Lots 1 to 16 inclusive, Plan M-64 and Lots 64 to 80 inclusive, Plan M-36, where the maximum height shall be 70 feet (excluding penthouse) so that the section shall now read:

Section 7 Sub-section 3(c)

Basic height, maximum 35 feet, except on the property described as Lots 1 to 16 inclusive, Plan M-64 and Lots 64 to 80 inclusive, Plan M-36, where the maximum height shall be 70 feet (excluding penthouse).

2.

THIS BY-LAW shall come into full force and effect upon the final passing thereof subject to the approval of the approval of the Ontario Municipal Board.
