Whereas the connectivity of Highway 417/17 is a key to the economic development of Northern Ontario as it links Canada through this nationally significant northern trade corridor and Highway 417/17 acts as a crucial transportation backbone connecting both the Provinces of Ontario and Quebec and Canada's Western Provinces to our Atlantic Provinces and the US Eastern Seaboard as well as the various communities throughout and around Northern and Eastern Ontario;

And Whereas the expansion of Highway 417/17 through Renfrew County to North Bay enhances transportation corridors to and from northern and northwestern Ontario consistent with the Province's Northern Ontario Multimodal Transportation Strategy and the Growth Plan for Northern Ontario and provides an enhanced connection between the deepwater ports along the St. Lawrence Seaway and the future "Northern Corridor" identified by the University of Calgary, School of Public Policy;

And Whereas The businesses in Northern and Eastern Ontario have a significant positive impact on the economies of Ontario and Canada and approximately 115 million tonnes of freight are moved through and within Northern Ontario annually, valued at approximately \$160 billion in the forestry, natural resources, agribusiness, construction and manufacturing sectors;

And Whereas trucks move approximately 28% of the total freight (32 million tonnes) at an estimated value of \$80 billion and commercial vehicle traffic is forecasted to increase by 67% in the region by 2041and the expansion of Highway 417/17 allows for expanded use of Long Combination Vehicles (LCV's) for the efficient and economic movement of Goods between Northern Ontario and the Deep Water ports as our communities and all municipalities, consumers and producers can benefit from predictable, economical and sustainable delivery of products and goods to our communities, and to ensure timely and economical delivery of our products to Canadian, North American and International markets;

And Whereas the Eastern Ontario Transportation Needs Analysis has identified the widening of Highway 17 to four lanes between Arnprior and North Bay as the 7th priority out of 12 projects;

And Whereas the continued expansion of Highway 17 to four lanes enhances transportation corridors to/from northern and northwestern Ontario consistent with the Northern Ontario Multimodal Transportation Strategy prepared by the Province of Ontario;

And Whereas the construction of four lanes of highway 17 totaling 290 kilometres will generate over 50,000 person years of employment and increase Canada's GDP by \$7.1 billion and showcase Ontario's expertise in climate adaptable infrastructure and technologies and reduce the congestion along the 401 corridor and the GTHA;

Now Therefore Be It Resolved that the City of North Bay supports the County of Renfrew's request that the Province of Ontario identify continuing the extension of the four lanes of provincial Highway 417/17 through Renfrew County to North Bay as a significant provincial and national transportation project with tremendous economic benefit for the Corporation of The City of North Bay and for Northern Ontario and respectfully request the Province of Ontario allocate funding for the continued immediate extension of Highway 417 West of Scheel Drive to the Town of Renfrew, with a goal of completing the project as soon as possible and move immediately to continue planning and prepare for the future extension of Highway 417 through the County of Renfrew and with the planning and preparation for the four-laning of Highway 417 to North Bay and beyond.

And Further that a copy of this resolution be sent to the Honourable Premier Kathleen Wynne; all MPP's and MP's representing Northern Ontario; the Honourable Steven Del Duca Minister of Transportation; the Honourable Charles Sousa, Minister of Finance; the Federation of Northern Ontario Municipalities; Patrick Brown, Leader of the Progressive Conservative Party of Ontario; Ms. Andrea Horwath, Leader of the Ontario New Democratic Party; and to the North Bay and District Chamber of Commerce.
