BY-LAW NO. 2001-95

BEING A BY-LAW TO AMEND BY-LAW NO. 139-95 BEING A BY-LAW RESPECTING THE ISSUE OF LICENSES IN THE CITY OF NORTH BAY

WHEREAS the Municipal Act, R.S.O. 1990, Chapter M-45, as amended, permits the Council to enact a Licensing By-law pursuant to the Licensing Power and Part 17 of the Act;

AND WHEREAS the fee payable for Mobile Food Vendors under Licensing By-law No. 139-95 is \$100.00 for non-powered vehicles and \$500.00 for powered vehicles annually;

AND WHEREAS the fee payable for Non-resident Hawkers and Pedlars under Licensing By-law No. 139-95 is \$500.00 for the first five days and \$50.00 for each day thereafter and for resident Hawkers and Pedlars is \$100.00 annually;

AND WHEREAS the Downtown Improvement Area has requested that Council consider a reduced fee for Mobile Food Vendors and Hawkers Pedlars for special events designated as municipal events;

AND WHEREAS the Council deems it desirable to amend the licensing by-law to allow a Special Event, five day license for multiple food vendors and for Hawkers and Pedlars for such events:

AND WHEREAS Council passed Resolution No. 2001-465 at its meeting held July 23, 2001, directing that the by-law be amended to allow the Special Event five day license and set a license fee and adopted Clause No. 2 of General Government Committee Report No. 2001-22 on September 10,2001, to allow the Special Event five day license fee for Hawkers and pedlars;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

That Schedule "1" to Licensing By-law No. 139-95 be amended by adding the

following license fees:

Hawkers and Pedlars – Non Resident \$100.00 for first vendor and and Resident for designated Municipal \$75.00 per additional vendor events
