BEING A BY-LAW TO AMEND BY-LAW NO. **2001-71**BEING A BY-LAW **TO** AUTHORIZE CHANGES TO
USER FEE SCHEDULES FOR THE VARIOUS
DEPARTMENTS AT CITY HALL
(SCHEDULE H- WATERFRONT MARINA SLIP RENTALS)

WHEREAS Section 200.1 of the Municipal Act authorizes the Council to pass by-laws imposing fees or charges for services or activities provided or done by or on behalf of the municipality and for the use of its property;

AND WHEREAS Section 102.1 of the Municipal Act authorizes the Council to delegate, by by-law, to **an** employee of the municipality any powers, duties or functions that are administrative in nature, excluding duties that are legislative or relate to passing by-laws, adopting estimates, levying taxes or making appointments to offices created by statute;

AND WHEREAS Council passed Resolution No. 2001-791 at its meeting held December 17,2001, to include Waterfront Manna slip rental rates under the Public Works and Services Schedule to By-law No. 2001-71;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. That Schedule "H' to By-law No. 2001-71 be hereby amended by including the Waterfront Marina Slip Rentals Rates attached hereto and forming **part** of this by-law.
- 2. This by-law comes into force and effect upon passing.
