

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 166-91

BEING A BY-LAW TO PROVIDE THE SUM OF \$147,300.00 TO THE NORTH BAY-MATTAWA CONSERVATION AUTHORITY TO DEFRAY THE COST OF ITS VARIOUS PROGRAMMES.

WHEREAS a Statement of Apportionments of the cost of the 1991 Flood Warning System, the Chippewa Creek Flood Damage Reduction Programme, the Parks Creek Environmental Assessment Study and the Lake Nipissing Shoreline Erosion Control Study have been given to the Corporation pursuant to Section 26 of the Conservation Authorities Act, R.S.O. 1980, Chapter 85.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY, PURSUANT TO THE PROVISIONS OF THE CONSERVATION AUTHORITIES ACT, R.S.O. 1990, CHAPTER 85, SECTION 26 (3) HEREBY ENACTS AS FOLLOWS:

1. That Capital funds in the sum of \$147,300.00 be provided to the North Bay-Mattawa Conservation Authority for the Chippewa Creek Flood Damage, the 1991 Flood Warning Programme, the Parks Creek Environmental Assessment Study and the Lake Nipissing Shoreline Erosion Control Study as more particularly set out in Schedule 'A' attached to and forming part of this By-Law.
2. That the Treasurer of The Corporation of the City of North Bay hereby be authorized to borrow from time to time from any bank or person, by way of promissory note or notes, temporary advances of money to meet the cost of the aforesaid Chippewa Creek Flood Damage Reduction Programme, the Flood Warning Programme, the Parks Creek Environmental Assessment Study and the Lake Nipissing Shoreline Erosion Control Study, pending the issue and sale of the debentures hereinafter referred to, but in no event shall the aggregate of such borrowing exceed the amount limited in this By-Law.
3. That the debentures to be issued for payment of the net cost of the aforesaid Chippewa Creek Flood Damage Reduction Programme, the Flood Warning Programme, the Parks Creek Environmental Assessment Study and the Lake Nipissing Shoreline Erosion Control Study, shall bear interest at such rate as the Council may determine and shall be made payable within ten (10) years on the installment plan.
4. This By-Law shall not become effective until approval in writing has been secured from The Ontario Municipal Board pursuant to Section 64 (1) of The Ontario Municipal Board Act, R.S.O. 1980, Chapter 347.

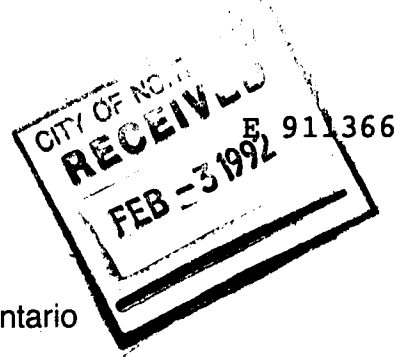

- (a) on its own behalf, the undertaking of the Chippewa Creek Flood and Erosion Control Program, Flood Warning, Parks Creek Environmental Assessment and Lake Nipissing Shoreline Erosion Control Study at an estimated cost of \$982,000.00 of which amount the sum of \$147,300.00 shall be contributed by The Corporation of the City of North Bay
- (b) on behalf of The Corporation of the City of North Bay, the borrowing of money by way of temporary advances not exceeding in the aggregate the sum of \$147,300.00 being its contribution to the estimated cost of the said undertaking, pending the sale of debentures, and the issuance of debentures to provide the said sum repayable over a term not in excess of ten years

THE BOARD ORDERS that this application be granted and that (1) The North Bay-Mattawa Conservation Authority may proceed with the said undertakings at an estimated cost of \$982,000.00 and may borrow money therefor, and (2) The Corporation of the City of North Bay may pass all requisite by-laws and may borrow money for the purpose of its contribution and may issue debentures therefor in an amount

sufficient to provide a sum not exceeding \$147,300.00 for a term not to exceed ten years, provided that the said Conservation Authority and the Council of The Corporation of the City of North Bay in exercising any power approved by this order shall comply and conform with all statutory and other legal requirements related thereto.
