The above citied by-law has been approved by The Honourable George E. Gomme, Minister of Highways, subject to the limitation that the <u>subsidy</u> payable for work performed under this by-law, together with the subsidy payable under the by-law (s) previously approved, shall not in total exceed

\$ 145,400	for	Construction
\$ 325,000	for	Maintenance

This approval is also subject to the following conditions:

- 1. That the individual works of road construction and bridge construction shall be subject to the approval of the District Engineer.
- 2. That tenders for work to be undertaken by contract shall be publicly advertised and Department subsidy shall apply on the amount of the lowest tender only unless the Municipal Engineer approves subsidy on a higher tender.
- 3. In the event that any portion of the cost of the proposed work or purchase is to be raised in a subsequent year or financed by the issue of debentures, the approval of the Ontario Municipal Board must be obtained before the work or purchase is authorized or any commitment made with respect thereto.
