

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 2225.

Being a by-law authorizing the sale and transfer of Lot No. 15 and Lot No. 16 as shown on Plan 53 for the City of North Bay and also the stopped-up portion of Robert Street as shown on the said plan immediately adjoining the said lots to Nipissing Area Joint Hospitals Laundry Incorporation for the purposes hereinafter set forth and upon and subject to the terms and conditions hereinafter set forth.

WHEREAS Nipissing Area Joint Hospitals Laundry Incorporation with its Head Office at the City of North Bay in the District of Nipissing was incorporated for the following principal objects or purposes:

(a) To arrange for a laundry service to public general hospitals and related health facilities in the District of Nipissing.

(b) To promote, in co-operation with the participating public general hospitals and related health facilities, research for the better rendering of laundry, cleaning, dyeing and repairing service pertinent to the medical and surgical treatment of patients;

AND WHEREAS the Corporation is desirous of the North Bay Civic Hospital and St. Joseph's General Hospital, North Bay, Ontario, obtaining economical laundry and linen services;

AND WHEREAS Nipissing Area Joint Hospitals Laundry Incorporation has applied to the Council of the Corporation of the City of North Bay for a grant of land to be used as a laundry site;

AND WHEREAS the Council of the Corporation of the City of North Bay deems it advisable to make the necessary grant of land to the said Corporation upon and subject to the terms and conditions set forth in that certain Deed of land dated the 16th day of August 1965.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That the following lands, namely:

ALL AND SINGULAR those certain parcels or tracts of land and premises situate lying and being in the City of North Bay in the District of Nipissing and more particularly described as follows:

FIRSTLY: Lot No. 15 and Lot No. 16 as shown on Plan 53 for the City of North Bay registered in the Registry Office for the Registry Division of the District of Nipissing;

SECONDLY: The whole of that part of Robert Street (now closed) formerly shown on Plan 53 for the City of North Bay aforesaid, lying between and immediately adjoining Lot No. 15 and Lot No. 16 aforesaid and which may be more particularly described as follows:

COMMENCING at the North-westerly angle of Lot No. 16 aforesaid;

THENCE Westerly along the Southerly boundary of Main Street as shown on the said Plan to the North-easterly angle of Lot No. 15 aforesaid;

THENCE Southerly along the Easterly boundary of Lot No. 15 a distance of 105' 1" to the South-easterly angle of said Lot No. 15;

THENCE Easterly and parallel to the Southerly boundary of Main Street aforesaid to the South-westerly angle of said Lot No. 16;

THENCE Northerly along the Westerly boundary of said Lot No. 16 a distance of 105' 1" to the point of commencement,

be granted or deeded to Nipissing Area Joint Hospitals Laundry Incorporation upon and subject to the terms, conditions and restrictions set forth in that certain Deed of land dated the 16th day of August 1965.

2. That the Mayor and the Clerk be and they are hereby authorized to execute the said Deed on behalf of the Corporation and to affix thereto the Corporate Seal.
