BY-LAW NO. 1599

BEING a By-Law for licensing, regulating and governing persons who go from place to place or to a particular place with goods, wares or merchandise for sale, or who carry and expose samples, patterns or specimens of any goods, wares or merchandise which is to be delivered in the Municipality afterwards.

THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS;

- 1. That in this By-Law, except where it is otherwise implied or shown by the context, the word "person" shall include not only an individual, but also any body corporate or politic and the heirs, executors, administrators or other legal representatives of a person to whom the context can apply according to law and words importing the singular number or the masculine gender only shall include more persons, parties of things of the same kind than one, and females as well as males and the converse.
- 2. That the words "Corporation", "Treasurer" and "Chief Constable" shall mean respectively the Corporation, Treasurerand Chief Constable of the City of North Bay.
- 3. No person shall engage in or carry on the trade, occupation or business of going from place to place or to a particular place with goods, wares or merchandise for sale, or who carry and expose samples, patterns or other specimens of any goods, wares or merchandise which is to be delivered afterwards within the City of North Bay unless or until he has procured a license authorizing him so to do and shall have paid to the Treasurer the fee hereinafter mentioned, and no such license shall be issued until such fee has been paid.
- 4. No such license shall be required for hawking, peddling or selling goods, wares or merchandise,
 - (a) to wholesale or retail dealers in similar goods, wares or merchandise, or
 - (b) if the goods, wares or merchandise are grown, produced or manufactured in Ontario and are hawked, peddled or sold by the grower, producer or manufacturer or his agent or employee having written authority so to do, in the municipality in which the grower, producer or manufacturer resides, or
 - (c) if the goods, wares or merchandise are grown or produced by a farmer resident in Ontario who offers for sale or sells only the produce of his own farm, or
 - (d) if the goods, wares or merchandise are hawked, peddled or sold by a person who pays business tax in the municipality or by his employee, or by his agent, or
 - (e) if the goods, wares or merchandise are hawked, peddled or sold by an agent of the grower, producer or manufacturer, acting on behalf of a dealer who pays business tax in the municipality in respect of premises used for the sale of such goods, wares and merchandise.
- 5. The annual fee for a license to act as hawker or pedlar within the City of North Bay shall be as follows:
 - (a) For a person with a motor vehicle \$100.00 (b) For a persons with a horse-drawn vehicle 100.00 (c) For a person with a push-cart 50.00
 - (d) For a person on foot, with or without a basket or pack, etc. 50.00
 - (e) For a person carrying samples, etc., the same fee as for a person selling goods according to the above mentioned scale of fees.
- 6. Such licenses shall be issued by the Treasurer, shall bear the seal of the Corporation and shall be signed by the Treasurer and shall not be transferable.
- 7. The licensee shall at all times whilst carrying on his business in the said City have his license with him, and shall upon demand exhibit it to the

Chief Constable or other peace officer, having jurisdiction in the City of North Bay, and if he fails to do so shall, unless the same is accounted for satisfactorily, in cur a penalty of not less than \$1.00 or more than \$5.00.

- 8. If the Chief Constable or other such peace officer demands the production of a license by any person to whom the by-law applies and the demand is not complied with, it shall be the duty of such peace officer, and he shall have the power to arrest such person without warrant and to take him before the nearest justice of the peace, there to be dealt with according to law.
- 9. Everyone exercising the calling of hawking or peddling of fruits, vegetables, or garden produce of any sort and being a bona fide grower of same but being a non-resident of the District of Nipissing shall have such goods inspected and approved as fit for sale by the market clerk of the City of North Bay before offering same for sale.
- 10. Any person convicted of a breach of any of the provisions of this by-law shall forfeit and pay at the discretion of the convicting Magistrate, a penalty not exceeding (Exclusive of costs) the sum of \$50.00 for each offense, which penalty may be recoverable in the manner provided by the Municipal Act.
- 11. This By-Law shall come into force on approval by the Department of Municipal Affairs.
