

BY-LAW NO. 1807.

BEING A BY-LAW to amend By-law No. 1779, a By-law to authorize the revision of Salaries of Department Heads and Secondary Department Heads not already covered by Union Agreement.

WHEREAS the Council of the Corporation of the City of North Bay did, by authority of Resolution No. 14 passed at a regular meeting of City Council, authorize By-law No. 1779 to be amended to include Professional and Supervisory Staff Employees who are not covered by Union Agreement.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. That By-law No. 1779 be amended to include Professional and Supervisory Staff Employees who are not covered by Union Agreement.
2. That said amendment be contained in Schedule "A" attached hereto and forming part of this By-law.
3. That the Salary Schedule with annual increments and effective dates as referred to in Schedule "A" attached hereto and forming part of this By-law, be the salary Schedule for Professional and Supervisory Employees not covered by Union Agreement.

BY-LAW NO. 1807

To establish a minimum and maximum salary schedule with annual increments and effective dated for the positions listed herewith, being Professional and Supervisory Staff Employees not covered by Union Agreement, in accordance with Resolution No. 14 passed at a regular Council Meeting of today, May 14th, 1956.

That in accordance with the Salary Schedule above, the following will be effective date and applicable rate for employees concerned at such dated:-

That Cyril T. C. Armstrong, B.Sc., be appointed as Civil Engineer at a starting salary of \$4800.00 effective May 7th, 1956, subject to the usual 6 months probation.

That John Frechette be appointed as Engineering Assistant at \$3250.00 effective January 1st, 1956.

That Walter Kannegiesser be appointed as Instrument Man at \$2975.00 per year effective May 1st, 1956.

That Bert Saunders be appointed as Draftsman at \$2400.00 per year effective January 11th, 1956.

That Elmer Simms be appointed as Inspector of Licenses and Parking Meters at a salary of \$3000.00 per year effective March 1st, 1956.

That Stanley Gore be appointed Pumphouse Superintendent at a salary of \$3300.00 per year exclusive of living accommodation provided by the City of North Bay and valued at \$476.40 per year.

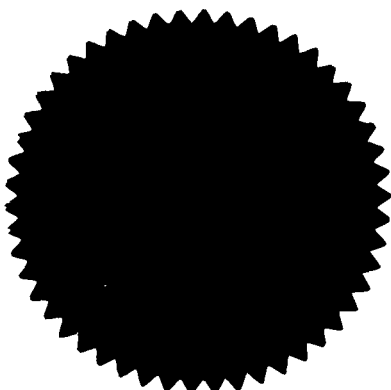
