BY-LAW regulating and licensing travelling shows, circuses, menageries, circus riding, rope-walking, merry-gorounds etc., in the City of North Bay, and the issuing of licenses in respect thereof.

WHEREAS the Municipal Council of the City of North Bay deem it desirable to license, regulate and govern all persons employed in any of the several trades, occupations, callings or business hereinafter set forth in this By-Law.

THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:-

1. THAT By-Laws numbers 800 and 1018 be and the same are hereby repealed.

2. No person or persons shall carry on any of the several trades, occupations, callings or business mentioned in the next succeeding sections of this By-Law unless and until he or they shall procure a license so to do as set forth herein and every such person or persons shall be subject to the provisions of this By-Law.

### 3. <u>CIRCUS</u>:

٢

There shall be paid for a license to hold or exhibit a travelling circus or menagerie, hippodrome or other like travelling exhibition, a fee of Two Hundred and Fifty Dollars (\$250.00) and for each side show or other entertainment connected or associated with such circus, menagerie or other exhibition, a fee of Thirty-five Dollars (\$35.00).

## 4. <u>MIDWAYS</u>:

There shall be paid for a license to hold or exhibit a travelling midway consisting of sideshows and rides or other like travelling exhibitions a fee of \$75.00 per day.

5. No such circus, midway, exhibition or entertainment connected with such, under paragraphs 3 and 4 of this By-Law shall be exhibited in the City of North Bay for a longer period than <u>ONE DAY</u> unless with the permission of the Chief of Police and unless a new license is taken out for each day such exhibition, or show is exhibited.

# 6. <u>SINGLE RIDES OR AMUSEMENTS</u>:

There shall be paid for licensing other places of like amusement, merry-go-rounds, switch back railways, carousals, and other like contrivances, a license fee of Twenty Dollars (\$20.00) each for each day of such exhibition.

# 7. <u>SINGLE EXHIBITIONS</u>:

There shall be paid for a license to exhibit for hire or profit wax works, rope-walking, dancing, tumbling or other acrobatic or gymnastic performance, wild animals, sparring, sleight-of-hand, ledgerdemain, boxing, jugglery, or other like tricks, natural or artificial curiosities, tableaux, wonderful animals or Treaks of nature, orany other exhibition kept for hire or profit, when the same is exhibited in any building or other place, other than a theatre, music or concert hall or other building, or place duly licensed, under this By-Law, for each day of such exhibition a fee of Ten Dollars (\$10.00) each.

## 8. <u>PICTURES ETC</u>.:

There shall be paid for a license to exhibit pictures, paintings, statutary or works of art, for each day of such exhibition a fee of Five Dollar s (\$5.00) each exhibition. MOVING PICTURES ETC .:

For a license for the performance of any troupe or company of actors, musicians, or Dramatic or musical performers or exhibition of sterescopic views or moving pictures, not residents of the City where such performance is given elsewhere than in a licensed theatre, music or concert hall, building, tent or other place, for each day a fee of Ten Dollars (\$10.00) each.

# 10. <u>PARADES</u>:

•For a license to conduct a street parade of any circus, menagerie or other like show where the exhibition is given outside the limits of the City of North Bay, ONE HUNDRED DOLLARS (\$100.00) for each parade.

11. The act of the wife, servant, clerk or other employee of any person licensed to carry on any business, trade or calling under this By-Law shall be deemed and taken to be the act of the licensee and the licensee shall be held responsible therefor, as though he had done the act himself and where the word person occurs in this By-Law it shall mean or include one or more persons as the case may be.

### 12. <u>PHOTOGRAPHERS</u>:

For a license for the carrying on of a photographing business when same is done in tents or other temporary structures, a fee of not less than Five Dollars (\$5.00) for each day that such business is carried on.

13. A license shall not be granted for any such exhibition or show mentioned herein to be held on the days of the exhibition of any district or township agricultural society, within 300 yards from the grounds of the society or for any such exhibition or show or in connection with which gambling is carried on or goods, wares or merchandise are sold or trafficed in.

14. Any person convicted of a breach of this By-Law shall forfeit and pay at the discretion of the Convicting Magistrate a penalty in case of violation of Section3 of this By-Law of Two Hundred and Fifty Dollars (\$250.00); in case of violation of section four (4) and ten (10) of this By-Law the sum of One Hundred Dollars (\$100.00); in case of violation of Sections eight (8) and twelve(12) of this By-Law a sum of Five Dollars (\$5.00); and in case of violation of Section seven (7) of this By-Law the sum of Ten Dollars (\$10.00); and in case of a violation of section six (6) of this By-Law, the sum of Twenty Dollars (\$20.00); and in case of the violation of Section nine (9) of this By-Law a sum of Ten Dollars (\$10.00) exclusive of costs in each case, and in default of payment of said penalty and costs forthwith the said penalty and costs or costs only may be levied by distress and sale of the goods and chattels of the offender, and in case of there being no distress found out of which the said penalty could be levied the convicting Magistrate may commit the offender to the common gaol of the City of North Bay with or without hard laber, for any period not exceeding ninety days, unless the said penalty and costs be sooner paid and for a breach of any of the provisions provided for under Sections Three, Four and Six, seven, eight, the said penalties may be levied by distress and sale of the showman or proprietor of belongings to or used in such exhibition or show whether owned or not owned by such showman or proprietor.
