BY-LAW NO. 2010-95

A BY-LAW TO AMEND BY-LAW NO. 2002-133  
(BEING A BY-LAW TO CONFIRM THE ROADS AND  
STREETS MAINTAINED BY THE CITY OF NORTH  
BAY)

WHEREAS Section 31(2) of the *Municipal Act*, S.O. 2001, as amended, authorizes a Municipality to pass a By-Law to establish a highway;

AND WHEREAS by Resolution No. 2008-502 passed by Council on Monday, July 7, 2008, Council authorized the acquisition of vacant property as part of the Traffic Roundabout at McKeown Avenue and College Drive.

AND WHEREAS by Resolution No. 2009-604 passed by Council on Monday, September 22, 2009, Council authorized the acquisition of vacant property comprised of Parts 2, 3, 5 and 6, Plan 36R-12228 and Parts 1, 2 and 3, Plan 36R-12674 as part of the Traffic Roundabout at Gormanville and McKeown Avenue.

AND WHEREAS by Resolution No. 2010-161 passed by Council on Monday, March 8, 2010, the subdivision agreement for the Pearce Street extension was approved and accepted the streets and the three metre reserves.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. By-Law 2002-133 is hereby amended by adding the attached Schedule "D".
2. This By-Law comes in effect upon being passed.
