<u>Res. #2006-211:</u> Moved by Councillor Anthony, seconded by Councillor Vaillancourt WHEREAS the Ontario Medical Association (OMA) has released a report entitled "Ontario Physician Shortage 2005";

AND WHEREAS said report predicts the provincial physician shortage will reach 2,300 this year;

AND WHEREAS the OMA estimates there are over 10,000 Canadian trained physicians practicing in the United States (US);

AND WHEREAS allowing US physicians, with recognized equivalency to commence practice in Ontario, might facilitate the influx of some doctors to this province in a relatively short period of time;

AND WHEREAS we in the North, have seen great strides and potential with the framework for the Northern Ontario Medical School, but the school is not the only solution to our larger physician shortage issues;

BE IT THEREFORE RESOLVED THAT the City of North Bay join the Township of Malahide in requesting that the Ontario Ministry of Health propose an amendment to the *Medicine Act*, that would allow the licensing of US and foreign trained physicians, that are in good standing, and have written the necessary examinations;

AND FURTHER THAT copies of this resolution be forwarded to Premier Dalton McGuinty; George Smitherman, Minister of Health; Monique Smith, MPP Nipissing; to Ontario's Oppositions Leaders, Federal Minister of Health, and to the North Bay Doctor Recruitment Committee.

> AND WHEREAS the average per capital cost for City of North Bay residents for these services was approximately \$448 per person in 2006;

AND WHEREAS the unincorporated townships use the above named services and contribute little or nothing to them, and the Provincial Treasury pays for their services via various taxes by approximately 95% of taxpayers residing in incorporated areas;

AND WHEREAS the Provincial Government has been petitioned in the past to rectify this situation with no action forthcoming;

AND WHEREAS the Provincial Government has the means to rectify this disparity;

BE IT THEREFORE RESOLVED THAT the Provincial Government be petitioned to take immediate action to correct this situation,

AND FURTHER THAT this resolution be forwarded to the Premier of Ontario, the Minister of Finance, Monique Smith MPP Nipissing, the Federation of Northern Ontario Municipalities, and to the Leaders of the Opposition.
