By-Law No. 2023-02

**Being a By-Law to Authorize User Fees
For City Departments**

Whereas Section 391 of the *Municipal Act, 2001* (S.O. 2001, c.25) authorizes municipalities and local boards to pass by-laws imposing fees or charges on any class of person for services or activities provided or done by or on behalf of the municipality or the local board and for the use of its property;

And Whereas Notice of the Public Meeting in the matter of user fees charged by various City Departments (Planning Department – Short Term Rentals) was published pursuant to the City of North Bay Notice By-Law 2020-79 section 2(b) on the City of North Bay Website on June 23, 2022;

And Whereas Notice of the Public Meeting in the matter of user fees charged by various City Departments was published pursuant to the City of North Bay Notice By-Law 2020-79 section 2(b) on the City of North Bay Website on December 23, 2022;

And Whereas a Public Meeting under the *Municipal Act* in the matter of the user fees charged by various City Departments (Planning Department – Short Term Rentals) was held on the 12th day of July, 2022;

And Whereas a Public Meeting under the *Municipal Act* in the matter of the user fees charged by various City Departments was held on the 10th day of January, 2023;

And Whereas Council passed Community Service Committee Report No. 2023-01 at its Regular Meeting held Tuesday, January 17, 2023 to authorize a By-Law for User Fees charged by various City Departments (Planning Department – Short Term Rentals);

And Whereas Council passed General Government Committee Report No. 2023-02 at its Regular Meeting held Tuesday, January 17, 2023 to authorize a By-Law for User Fees charged by various City Departments effective the 1st day of February, 2023.

Now Therefore the Council of The Corporation of the City of North Bay does hereby enact as follows:

2. All fees and charges set out in this by-law shall be payable prior to the provision of the service unless an agreement in writing is made to the contrary and approved by a municipal official.

3. (a) In the event any fee or charge imposed herein remains unpaid after provision of the service or is otherwise in arrears, such fees or charges may be added to the Tax Roll for any real property in the municipality, the owner of which is responsible for paying the fee or charge and shall be collected in like manner as municipal taxes.
- (b) In default of payment of any charge levied herein, by the required due date for the payment thereof, a percentage charge of one and one-quarter per cent (1¼%) is hereby imposed as a penalty for non-payment of such charge thereof, and such penalty shall be added to the charge as aforesaid or any instalment or part thereof remaining unpaid on the first day of each calendar month thereafter in which default continues.

4. Council does hereby delegate to municipal staff of The Corporation of the City of North Bay, the authority to administer such fees and charges and approve such forms and procedures as may be required for the efficient administration of the fees and charges.

5. This By-Law shall come into force and effect as of the 1st day of February, 2023.

6. By-Law No. 2019-07, as amended, is hereby repealed as of the 1st day of February, 2023.

Attendant Card – A person who requires an attendant may purchase an “Attendant Photo I.D. Card (\$10.00) which enables the attendant to ride free.

C.N.I.B. – A person registered with the “Canadian National Institute for the Blind”. When the card is presented the individual rides free.

Bus passes require a transit photo ID card, which are \$10.00.
