## **BY-LAW NO. 2006-57**

BEING A BY-LAW TO STOP UP, CLOSE AND CONVEY
A PORTION OF THE DASHNAY STREET ROAD ALLOWANCE
ABUTTING LOTS 104 & 125, PLAN 15 AND LOTS 30 TO 37, PLAN 89
IN A BLOCK BOUNDED BY McINTYRE STREET WEST, NIPISSING STREET,
COPELAND STREET AND ROCK STREET,
IN THE CITY OF NORTH BAY

WHEREAS it is deemed expedient and in the interest of The Corporation of the City of North Bay that part of the Dashnay Street road allowance abutting Lots 104 and 125, Plan 15, and Lots 30 to 37 (both inclusive), Plan 89 be closed, stopped up and sold at its appraised value;

**AND WHEREAS** by Resolution No. 2005-199 passed on the 29<sup>th</sup> day of March, 2005, Council approved the closure of part of the Dashnay Street road allowance designated as Part 1, Plan 36R-12021;

**AND WHEREAS** by Resolution No. 2005-718 passed on the 17<sup>th</sup> day of October, 2005, Council approved the closure of part of the Dashnay Street road allowance designated as Part 2, Plan 36R-12021;

**AND WHEREAS** that part of the Dashnay Street road allowance abutting Lots 104 and 125, Plan 15, and Lots 30 to 37 (both inclusive), Plan 89 is hereby declared to be surplus;

**AND WHEREAS** notice of this by-law was published once a week for two consecutive weeks in the North Bay Nugget, published in the City of North Bay;

**AND WHEREAS** no person has claimed that his lands will be prejudicially affected by the passing of this by-law nor applied to be heard in person or by his counsel, solicitor, or agent, the Council of the City nor a Committee of said Council:

## NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- That certain part of the Dashnay Street road allowance abutting Lots 104 and 125, Plan 15, and Lots 30 to 37 (both inclusive), Plan 89 designated as Parts 1 and 2, on Reference Plan 36R-12021 is hereby closed, stopped up and conveyed.
- 2. This by-law comes into force and effect upon a certified copy of the by-law being registered in the Land Titles Office for the District of Nipissing.

READ A SECOND TIME IN OPEN COUNCIL THE 27<sup>TH</sup> DAY OF MARCH, 2006.
