- h) approve a Conservation Program for 2016 to be funded from the Water Completed Capital Reserve for an amount of up to \$100,000.00, being a rebate program, for the installation of low flow toilets;

- i) consider assistance programs for the future; and
- j) re-affirm organizations using water in production of products may be exempt from wastewater charges as per clause 18 of the current City By-law No. 2015-88.
