The Community Services Committee presents Report No. 2005-35 and recommends:

- 1) water is a sacred gift the connects all life;
- 2) access to clean water is a basic human right;
- 3) the value of Earth's fresh water to the common good takes priority over any possible commercial value;
- 4) fresh water is a sacred legacy, a public trust, and a collective responsibility;

BE IT FURTHER RESOLVED THAT the Council of the City of North Bay call upon the Federal Government to urge the World Bank to ensure access to clean, affordable water for the world's poor, and strengthen the role of the public sector and individual communities in setting water policies and delivering and regulating water services.
