BY-LAW NO. 1707.

BEING A BY-LAW TO AUTHORIZE CONSTRUCTION OF A SEWAGE DISPOSAL PLANT IN THE CITY OF NORTH BAY.

WHEREAS the Council of the Corporation of the City of North Bay deem it advisable to provide for the construction of a sewage disposal plant in the said City.

AND WHEREAS the said sewage disposal plant and works contemplated here: under have been approved by the Department of Health for the Province of Ontario.

THEREFORE, THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY UNDER THE PROVISIONS OF THE MUNICIPAL ACT, R.S.O. 1950, Chapter 243, ENACTS AS FOLLOWS:

- 1. That a sewage disposal plant be constructed, such construction to include the securing of location, the influent sewer, the effluent sewer, the acquisition of private lands necessary to the location of the new sewage disposal plant and to provide authority for the diversion of Chippewa Creek from the vicinity of Memorial Drive to Lake Nipissing, all according to Plan 44A6 prepared by Kilborn Engineers, the estimated cost of all the works is \$685,000.00.
- 2. That the Consulting Engineer of the City be instructed to make all necessary plans, profiles and specifications forthwith, and to furnish such information as may be necessary for the making of a contract for the execution of the work or for the carrying on of the work by day labour.
- 3. That the work shall be carried on under the superintendence and according to the directions and orders of the Consulting Engineer of the City.
- 4. The Council may decide by resolution to carry on and execute the work by day labour.
- 5. In the absence of a resolution by Council that the work be carried on and executed by day labour, the Mayor and Clerk are hereby authorized to enter into a contract with some person or persons, firm or corporation for the construction of the work, subject to the approval of the Council by resolution.
- 6. The treasurer may, subject to approval of the Council, agree with any bank or person for temporary advances of money to meet the cost of the work pending completion of such work.
- 7. The debentures to be issued when the work is completed to pay for the cost of such work, shall bear interest at such rate as the Council may determine and shall be made payable within 20 years on the instalment plan.
- 8. That this By-Law shall not become effective until approval in writing has been secured from the Ontario Municipal Board pursuant to Sections 66 and 67 of the Ontario Municipal Board Act being R.S.O. 1950, Chapter 262.
