BEING A BY-LAW TO AMEND BY-LAW NO. 56-86  
BEING A BY-LAW TO AUTHORIZE THE SUM OF  
\$65,000.00 FOR THE PURCHASE OF PORTABLE  
STAGING FOR MEMORIAL GARDENS.

WHEREAS the Municipal Act R.S.O. 1980, Chapter 302, Section 208,  
Paragraph 57 provides for the work described in Schedule 'A',

AND WHEREAS the Council of The Corporation of the City of North  
Bay deems it desirable to increase the net amount to be  
debentured from \$57,500.00 to \$97,000.00.


NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF  
NORTH BAY HEREBY ENACTS AS FOLLOWS:


1. That paragraph 1 be amended by deleting the figure of  
\$65,000.00 in the second line and inserting in lieu  
thereof the figure \$104,500.00.
2. That Schedule 'A' attached to and forming part of  
By-law No. 56-86 be deleted and inserting in lieu  
thereof Schedule 'A' attached to and forming part of  
this by-law.
3. This by-law shall not become effective until approval  
has been received from the Ontario Municipal Board  
pursuant to The Ontario Municipal Board Act R.S.O. 1980,  
Chapter 347, Section 64(1).

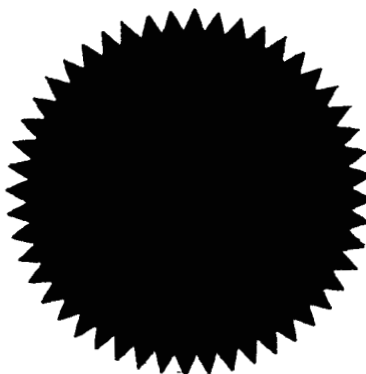
