BY-LAW NO. 2004-32

**BEING A BY-LAW TO AMEND BY-LAW NO 2001-71
BEING A BY-LAW TO AUTHORIZE CHANGES TO USER
FEE SCHEDULES FOR VARIOUS DEPARTMENTS AT
CITY HALL (RECREATION & LEISURE SERVICES)**

WHEREAS Section 391 of the *Municipal Act, 2001* (S.O. 2001, c.25) authorizes the Council and Local Boards to pass by-laws imposing fees or charges for services or activities provided or done by or on behalf of the municipality or the Local Board and for the use of the property;

AND WHEREAS the Council of the City of North Bay has deemed it desirable to amend By-law No. 2001-71 to increase fees charged to Park Vendors and passed Resolution No. 2004-87 at its meeting held on the 9th day of February, 2004.

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Schedule "L" attached hereto and forming part of this by-law be hereby added to User Fee By-law No. 2001-71.
2. That this by-law take effect upon being passed.



THIS IS SCHEDULE "L" TO BY-LAW NO. 2004-32 OF THE CORPORATION OF THE CITY OF NORTH BAY

The user fees charged for the Recreation and Leisure Services Department to Park Vendors shall be as set out below:

<u>Vendor Classification</u>	<u>2004</u>
<u>Designated Vendor</u> (defined as a vendor who will be granted a designated location for vending. The designated area shall be pre-established and will be decided by a lottery draw process.)	\$1,272.00 / season *
<u>Annual Designated Vendor</u> (defined as a vendor who, from time to time may develop a new product or service which requires a specialized designated location, and where the location is available and acceptable for such use.)	\$1,272.00 / season *
<u>Transient Vendor</u> (defined as a vendor who wishes to access park areas on an intermittent basis, and who may be mobile. This vendor has no pre-determined location. However, they are restricted to a variety of pre-determined transient locations in park areas which are available on a first come, first served basis.)	\$31.80 / month * or \$106.00 / season *
