AND WHEREAS one of the other partners in the Northeast Regional Distributor, is Hydro One, which will transfer its assets and considerable debt to the new Regional Distributor for shares in the new company;

AND WHEREAS the report titled, "Renewing Ontario's Electricity Distribution Sector: Putting the Consumer First" does not reference or have regard for the Northern Growth Plan;

AND WHEREAS Northeast Utilities Group (which North Bay Hydro is a member) made a submission to the Ontario Distribution Sector Review Panel recommending a Northern Ontario plan for the future.

BE IT THEREFORE RESOLVED that the City of North Bay forward a letter to the Honourable Dalton McGuinty, Premier of the Province; the Honourable Chris Bentley, Minister of Energy and Infrastructure; the Honourable Rick Bartolucci, Minister of Northern Development and Mines; Victor Fedeli, MPP; Tim Hudak, Leader of the Progressive Conservative Party of Ontario; Andrea Horwath, Leader of the Ontario New Democratic Party advising that the City of North Bay is not in support of amalgamating local Hydro Utilities, and Petition the Premier of the Province of Ontario and Minister of Energy once the new cabinet has been announced, to meet with representatives of the impacted municipalities;

AND FURTHER that a copy of this Resolution be sent to the Local Distribution Companies; North Bay and District Chamber of Commerce; Federation of Northern Ontario Municipalities (FONOM); Northwestern Municipal Association (NOMA) and the Association of Municipalities of Ontario (AMO).
