 - c) a temporary exclusion to Section D, Regulation 3B of the Municipal Alcohol Policy (Attachment 3) be approved, allowing the establishment of a licensed area to serve alcohol on Saturday, February 25, 2006 between 11:00 a.m. 7:00 p.m. and Sunday, February 26, 2006 between 11: 00 a.m. 6:00 p.m. at the location, as defined in Attachment 1(Licensed Area), under the following conditions:
 - the group reviews the details of the Municipal Alcohol Policy;
 - the beer tent organizer meets with staff to review the policy and sign the Special Occasion Permit Agreement at least fifteen (15) days prior to the event;
 - a part-time City security person be retained by the event host with costs borne by the host;

- all other relevant sections of the Municipal Alcohol Policy be satisfied; and
- d) to allow a temporary snowmobile access trail from Lake Nipissing, along Memorial Drive to the CP rail crossing, to the service route leading to the event site, as per Attachment 1 (Snowcross access route).
