And Whereas many communities of similar size issue fire permits in both their rural and urban areas;

Therefore Be It Resolved that Council direct the Chief Administrative Officer to review the existing Open Air Burning By-Law with the following considerations:

- 1. amend the zones and move towards a system that would allow properties that fit the regulated parameters, to have a covered pit purchased from a retailer and/or an open fire pit, which would expand the number of households in both the rural and urban areas able to obtain a fire permit
- 2. amend the bylaw to allow multi-year permits to reduce administration costs
- 3. review the restrictions for having a recreational fire
- 4. update the current bylaw and make the wording consistent (e.g. times)

And Further that a Report be brought back to Council on or before August 31, 2014.
