- d) a further three persons are appointed as directors,
  - (i) one to both the Generation Company Board and the Retail Power Company Board,
  - (ii) one to both the Generation Company Board and the Services Company Board, and
  - (iii) one to both the Retail Power Company Board and the Services Company Board.
- e) these provisions are effective from and after January 1, 2003.
