## RECOMMENDATION

That Council approve a request by Miller & Urso Surveying Inc. on behalf of 1736262 Ontario Ltd. (Consolidated Homes Ltd.) for an extension to the expiry date, from April 3rd, 2012 to April 3rd, 2014, for the Draft Approved Plan of Subdivision comprising of eighteen (18) Residential Lots for Single Detached Dwellings and two (2) Blocks for Parkland Dedication purposes on Golf Course Road in the City of North Bay.

## BACKGROUND

A formal request has been received from Miller & Urso Surveying Inc. on behalf of 1736262 Ontario Ltd. to extend the expiry date from April 3rd, 2012 to April 3rd, 2014 on a Draft Approved Plan of Subdivision comprising of eighteen (18) Residential Lots for Single Detached Dwellings and two (2) Blocks for Parkland Dedication purposes on Golf Course Road in the City of North Bay, as shown on Schedules 'A' and 'B' attached hereto.

The Applicant has not yet proceeded with the planned residential development of the subject lands. A formal written request to extend the expiry date of the Draft Approval was received by Planning Services Staff on January 31<sup>st</sup>, 2012. The written request states the delay in the project is as a result of the exploration of different servicing options for the site and due to a perceived decline in the market for single detached dwellings in the area. The Applicant indicated that the servicing of the site has recently been approved by the City Engineer and construction of these services is expected to begin within the next year.

Section 51(33) of the Planning Act allows City Council to "extend the approval for a time period specified by the approval authority and may further extend it, but no extension is permissible if the approval lapses before the extension is given."

The subject lands were given Draft Approval for a Plan of Subdivision totaling eighteen (18) Residential Lots for Single Detached Dwellings and two (2) blocks for Parkland Dedication purposes by City Council (Resolution No. 2007-93). There has been no change in the status of the property, nor to the draft conditions attached as an Appendix to this report.

## **OPTIONS / ANALYSIS**

The status of the subject lands has not changed since the original Draft Approval in April of 2007 and the request to extend the expiry date is reasonable. The servicing of the site has recently been approved by the City Engineer and construction of these services is expected to begin within the next year.

## Option 1:

That Council approve a request by Miller & Urso Surveying Inc. on behalf of 1736262 Ontario Ltd. (Consolidated Homes Ltd.) for an extension to the expiry date, from April 3rd, 2012 to April 3rd, 2014, for the Draft Approved Plan of Subdivision comprising of eighteen (18) Residential Lots for Single Detached Dwellings and two (2) Blocks for Parkland Dedication purposes on Golf Course Road in the City of North Bay.

Option 2:

That Council not approve a request for an extension.

## RECOMMENDED OPTION

Option 1 is the recommended option.

This two (2) year extension would provide additional time for the Applicant to complete preservicing works prior to the Final Approval of the Plan of Subdivision. Final Approval of the Plan of Subdivision will be required prior to April 3, 2014.

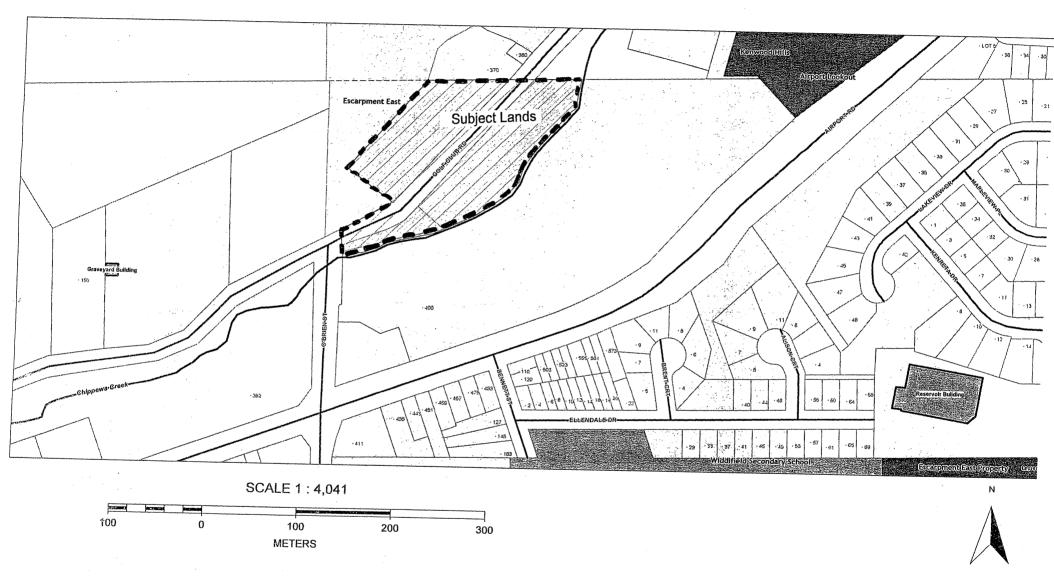

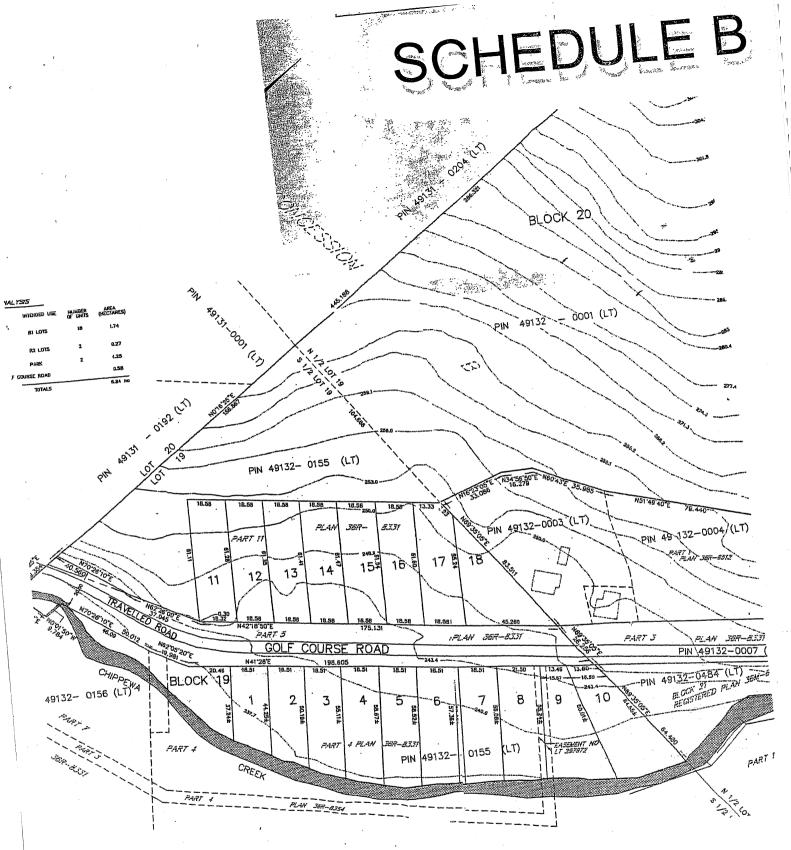

## APPENDIX "A"

The City of North Bay's Conditions to Final Approval for registration of the Subdivision File No. 48T-06102, are as follows:

<u>No.</u>

## <u>Conditions</u>

- 1) That this approval expires five (5) years from the date of approval shown by the "Draft Plan Approval Stamp" on the face of the draft plan. If there is an appeal to the Ontario Municipal Board under section 51 (39) of the *Planning Act*, the five (5) year expiration period does not begin until the date of the order of the Ontario Municipal Board issued in respect of the appeal or from the date of a notice issued by the Board under section 52(51) of the *Planning Act*.
- 2) This Draft Approval applies to the Plan of Subdivision prepared by R.D. Miller, OLS dated March 20, 2006 consisting of 18 lots for single detached dwellings and two blocks for Parkland Dedication.
- 3) That all streets on the Plan of Subdivision be named to the satisfaction of the City of North Bay.
- 4) That no removal of trees be undertaken prior to final approval except: within the proposed road allowance; for survey purposes around the boundary of the Draft Approved Lands and for exploratory soils investigations for the purpose of estimating servicing costs.
- 5) That the road allowance included in this Draft Plan shall be dedicated as public highways.
- 6) That any dead ends and open sides of road allowances created by this Draft Plan shall be terminated in 0.3 metre reserves to be conveyed to and held in trust by the Municipality.
- 7) That prior to signing the Final Plan by the Municipality, the proposed subdivision conform with the Zoning By-law in effect for the Municipality.
- 8) That the owner agrees in writing to satisfy all requirements, financial and otherwise of the City of North Bay concerning provision of roads, installation of services, and drainage.
- 9) That such easements as may be required for utility or drainage purposes shall be granted to the appropriate authority.
- 10) That the Owner provides full engineering drawings showing the provision of full municipal services including storm, sanitary sewers, water and full curb section, prepared by a qualified engineer, to the satisfaction of, and at no expense to the City of North Bay.
- 11) At the time construction is commenced, Golf Club Road shall be constructed to the current municipal collector standard, including the dedication of any required right-of-way widening

to accommodate such. Improvements to the O'Brien street roadway from the limit of the Subdivision to Airport Road may also be required. Costs associated with any improvements will be negotiated with the developer prior to pre-servicing and Final Approval.

- 12) Sanitary Sewer and Watermain services do not exist along the frontage of the proposed development. Significant offsite works will be required to bring these services into the proposed subdivision including looping the watermain. Any cost sharing associated with the extension of sewer and water services will be negotiated with the developer prior to pre-servicing and Final Approval.
- 13) That the Subdivision Agreement between the owner and the Municipality contain wording acceptable to the City Engineer to ensure that:
  - a) the owner agrees that a Stormwater Management Plan shall be undertaken by a professional engineer with respect to the Subdivision describing best management practices and appropriate measures to maintain quality storm runoff, both during and after construction and to ensure the quality and quantity of stormwater generated form the site does not compromise the quantity or quality of the water in the adjacent stream
  - b) The Stormwater Management report shall also address any slope stability or any hydrogeological issues associated with this development
  - c) Any recommendations forthcoming from the Stormwater Management Study shall be incorporated into the final Subdivision site design and implemented to the ongoing satisfaction of, and at no expense to, the Municipality.
- 14) That the Subdivision Agreement between the Owner and the Municipality contain wording acceptable to the City to ensure that:
  - a) A slope stability report is prepared for all lots within the subdivision, such report is to include, but is not limited to, a hydrogeological assessment and shall identify any potential groundwater concerns related to the construction of dwellings within the escarpment area
  - b) For final engineering design of the subdivision, a cross section for each and all lots will need to be prepared to ensure the integrity of the steeper portions of the escarpment is not compromised.
- 15) That the Subdivision Agreement between the owner and the Municipality contain wording acceptable to the City Engineer to ensure that:
  - a) the Contractor shall prepare a plan for the control of erosion and sediment, and shall accept responsibility for the adequacy of the plan prior to commencement of any excavation or grading work

- b) the Contractor shall provide the City with a copy of the plan and written notice confirming that appropriate agency reviews have been undertaken.
- c) the Contractor shall be solely responsible for controlling erosion and sediment including, but not limited to, the implementation, inspection, maintenance and removal of erosion and sediment control measures according to OPSS 577.
- d) the erosion and sediment control measures should accommodate other aspects of the work including, but not restricted to the following:
  - i. Work area requirements, including equipment access, operation and storage, and material supply, utilization and storage.
  - ii. Surface drainage from outside, through or around the work area.
  - iii. Areas of disturbed soil and soil stockpiles.
  - iv. Means of access to erosion and sediment control measures requiring maintenance.
  - v. Protection of completed portion of the work.
- 16) The Owner shall arrange, at the expense of the Owner, for a notice to be registered on title of the subject lands, notifying all future owners and leasees that a fifteen (15) metre buffer shall be maintained in its natural state along the bank of Chippewa Creek.
- 17) The Owner shall arrange, at the expense of the Owner, for a notice to be registered on title of the subject lands (Lots 11 to 18 inclusive), notifying all future owners and leasees that no tree removal shall be permitted without the approval of the City Engineer.
- 18) That the proponent shall carry out an archaeological assessment of the entire development property and mitigate, through preservation or resource removal and documentation, adverse impacts to any significant archaeological resources found. No demolition, grading or other soil disturbances shall take place on the subject property prior to the approval authority and the Ministry of Culture confirming that all archaeological resource concerns have met licensing and resource conservation requirements.
- 19) That the owner agrees to convey Block 19 and Block 20 to the Municipality for park or other public recreational purposes.
- 20) That the owner agrees to provide locations for centralized mail delivery acceptable to Canada Post Corporation or other alternative systems as may be normally required by Canada Post.
- 21) That the Subdivision Agreement between the owner and the Municipality be registered by the Municipality against lands to which it applies once the Plan of Subdivision has been registered prior to any encumbrances.
- 22) The subdivision agreement for the subject subdivision application shall include a statement informing the first purchaser of a lot within the subject Plan of Subdivision that prior to the issuance of a building permit, the purchaser will be required to pay Development Charges

- 23) That development charges be imposed in accordance with the current applicable Municipal Development Charges By-law.
- 24) That before City Council's Final Approval is given, the Council shall be advised in writing by the City of North Bay's Engineering and Environmental Services how Condition Nos. 11 and 12 have been satisfied.
- 25) That before City Council's Final Approval is given, the Council shall be advised in writing by the Director of Parks, Recreation and Leisure Services how Condition No. 13 has been satisfied.
- 26) That before City Council's Final Approval is given, the Council shall be advised in writing by Canada Post Corporation how Condition No. 14 has been satisfied.

## **NOTES**

- 1) We suggest you make yourself aware of the following:
  - a) Section 143(1) of The Land Titles Act, R.S.O. 1980 as amended, which requires all new plans to be registered in a land titles system.
  - b) Section 143(2) allows certain exceptions.
- 2) Prior to undertaking a site alteration, construction or renovation activities a Development, Interference with Wetlands & Alteration to Shorelines & Watercourses Permit is required from the North Bay-Mattawa Conservation Authority. The subject lands are within an area regulated by the North Bay-Mattawa Conservation Authority under Ontario Regulation 162/90. This regulation is pursuant to Section 28 of the Conservation Authorities Act of Ontario.
- 3) An electrical distribution line operating below 50,000 volts might be located within the area affected by this development or abutting this development. Section 186 Proximity of the Regulations for Construction Projects in the Occupational Health and Safety Act, requires that no object be brought closer than 3 metres (10 feet) to the energized conductor. It is the proponent's responsibility to be aware, and to make all personnel on site aware, that all equipment and personnel must come no closer than the distance specified in the Act. They should also be aware that the electrical conductors can raise and lower without warning, depending on the electrical demand placed on the line. Warning signs should be posted on wood poles supporting conductors stating "Danger Overhead Electrical Wires" in all locations where personnel and construction vehicles might come in close proximity to the conductors.
- 4) The Developer is hereby advised that prior to commencing any work within the Plan, the Developer must confirm that sufficient wire-line communication/telecommunication infrastructure is currently available within the proposed development to provide communication/telecommunication service to the proposed development. In the event that such infrastructure is not available, the Developer is hereby advised that the Developer may be required to pay for the connection to and/or extension of the existing

communication/telecommunication infrastructure. If the Developer elects not to pay for such connection to and/or extension of the existing communication/telecommunication infrastructure, the Developer shall be required to demonstrate to the municipality that sufficient alternative communication/telecommunication facilities are available within the proposed development to enable, at a minimum, the effective delivery of communication/telecommunication services for emergency management services (i.e., 911 Emergency Services).

### Describe your Drinking-Water System

The City of North Bay water treatment plant (WTP), water distribution facilities and water distribution piping system are owned by the Corporation of the City of North Bay. The Ontario Clean Water Agency was the Operating Authority for the WTP and water distribution facilities until June 30, 2011 at which point the City of North Bay took over operations. The City of North Bay has been Operating Authority for the WTP and water distribution facilities since June 30, 2011 at 16:00.

The City of North Bay Water Treatment System is classified as a "Large Municipal Residential" Drinking-Water System, Class 3 with Drinking-Water System Number: 220000460. The WTP, located at 248 Lakeside Drive in North Bay, treats water from Trout Lake which is part of the Mattawa River watershed. The WTP services a population of approximately 54,000 and the permit to take water permits consumption up to 79,500 cubic meters per day.

The water distribution facilities consist of the following:

Ellendale Reservoir, High lift Pump Station & Re-chlorination Facility; CFB Reservoir;

**Canadore Pumping Station;** 

Judge Avenue Valve Chamber & Re-chlorination Station;

Birches Road Standpipe and Re-chlorination Station; and

Airport Road Standpipe, Booster Pumping Station and Re-chlorination Facility.

The membrane filtration water treatment plant has the design capacity of 79,500 cubic meters per day. The plant is a SCADA controlled membrane filtration system with ultraviolet and chlorine disinfection systems. The plant also includes fluoride addition along with caustic pH adjustment prior to delivery to the distribution system.

The membrane filtration plant meets the Ontario Drinking Water Standards requirements for the removal/disinfection of 3-log Giardia Lambia, 2-log Cryptosporidium and 4-log Viruses. The membrane filtration Primary Barrier provides for a 3-log Giardia removal, 2-log Cryptosporidum removal. The chlorine/UV disinfection Secondary Barrier provides for a 0.5 UV Giardia removal, 0.5-log UV Cryptosporidum removal and a 4 log chlorine virus removal.

In general the North Bay WTP can be described as follows: Intake

A 1200mm diameter series 45 polyethylene intake pipe, with a capacity of 80,000 cubic meters per day. The pipe, constructed in 1973, extends approximately 300 meters into Delaney Bay of Trout Lake and includes an intake structure consisting of a stell inlet bell mouth with fibre reinforced plastic (FRP) cage and is in approximately 21.5 metres of water at low water level.

## Membrane Feed Pump Well/Prescreening

Two (2) parallel sub-surface well chambers with level monitoring containing, two (2) 6mm mesh manual prescreen in series, five (5) vertical turbine pumps (4 duty and one standby) rated at 20 m3/d feeing the primary membrane system.

## **Membrane Feed Strainers**

Five (5) 300 micron automatic membrane feed strainers (four duty and one standby).

## **Treatment Plant Process Areas**

A building housing the following process components:

- primary and secondary membrane filtration system;
- primary and secondary UV disinfection system;
- split chlorine contact tank;
- split highlift pump well

• three (3) chemical storage and delivery rooms housing membrane cleaning and neutralization chemical systems, pre-chlorination system, primary disinfection chemical system, residual chlorination chemical system, alkalinity adjustment system, and fluoride addition system;

- highlift pumping;
- Generator room;
- Electrical room.
- compressor/blower room

## **Treatment Plant & Administration Areas**

Two floor administrative area including laboratory/control room, server room, multipurpose training room, offices, washrooms, women's and men's locker rooms, janitor room, building mechanical room and storage room.

## Membrane Filtration

Eleven (11) pressurized primary membrane racks treating water from the membrane feed strainers, two(2) pressurized secondary membrane racks treating non-chemical backwash water from the primary membrane racks. The primary racks have a maximum production flow rate of 78.7 MLD based on raw water flow rate of 79.5 MLD, Ancillary systems including backwash pumps, instrument air for operating valves and integrity testing membranes, process blowers, and chemical cleaning and neutralization systems.

## **UV Disinfection Systems**

Three (3) 600mm UV reactors (two duty and one standby) treating water from the eleven (11) pressurized primary membrane racks and two (2) secondary membrane racks. Each reactor contains medium pressure high intensity lamps housed in quartz sleeve and equipped with self cleaning mechanism and intensity sensor.

High lift pump well #1 has a capacity of approximately 240 cubic metres and is equipped with one (1) variable speed and two (2) constant speed vertical turbine high lift pumps each rated at 20 MLD. High lift pump well #2 has a capacity of approximately 240 cubic meters and is equipped with one (1) variable speed and one (1) constant speed vertical turbine high lift pump each rated at 20 MLD.

#### **Generator Room**

One (1) dual fuel generator set (NG/Diesel) with a rating of 2050KW, to provide power during peak hours and emergency situations.

Wastewater Disposal System

Primary Membrane Backwash Tank Tank with a volume of approximately 310 cubic meters, Two (2) membrane feed pumps supplying water to the Secondary Membrane System.

The treated water is pumped to the distribution system.

The water distribution facilities can be described as follows:

Ellendale Reservoir, Highlift Pumping Station and Re-chlorination Facility The facility is a reinforced concrete at-grade, double cell, un-baffled, treated water reservoir, located at the east end of Ellendale Drive. The reservoir has an approximate capacity of 18,200 cubic meters, with dimensions of 71 meters by 38 meters by 7 meters. The facility is equipped with a sodium hypochlorite re-chlorination system, on-line continuous water quality analyzers for free chlorine and turbidity and a standby generator to operate the facility during power outages.

## Birchs Road Standpipe and Re-chlorination Station

The facility consists of one (1) 39 meter high, 19 meter diameter, 11,775 cubic meter capacity, steel, un-baffled, treated water standpipe, located near the southwest corner of Birchs Road and Booth Road. The facility is equipped with sodium hypochlorite rechlorination system, on-line continuous water quality analyzers for free chlorine and turbidity and fixed 7.5kW, 120/240 Volt single phase, diesel powered generator to power the re-chlorination and SCADA communications during prolonged power outages.

Judge Avenue Valve Chamber and Re-chlorination Station

The facility consists of a valve and re-chlorination station, located near the northeast corner of Judge Avenue and Lakeshore Drive, equipped with a sodium hypochlorite re-chlorination system, on-line continuous water quality analyzers for free chlorine and turbidity, a fixed 7.5kW 120.240 Volt single phase, diesel powered generator to power the re-chlorination and SCADA communications during prolonged power outages, and valve control that is integrated with Birches Standpipe.

## CFB North Bay Reservoir and Re-chlorination Facility

The facility consists of one (1) 1820 cubic meter capacity, un-baffled reservoir and a rechlorination facility located at the north end of Manston Crescent. The facility is equipped with a sodium hypochlorite re-chlorination system, on line continuous water quality analyzer for free chlorine and a standby pump to provide water during power outages.

## **Canadore Pumping Station**

The facility is equipped with highlift pumps and pressurized cushion tanks to maintain pressure in the pressurized zone of the distribution system servicing Canadore College and Nipissing University. There is an on-line continuous water quality analyzer to monitor free chlorine residual and a 200kW, 347/600 Volt, 3 phase diesel generator to provide power and SCADA communications during prolonged power outages.

## Airport Standpipe, Booster Pumping Station

This 4,000 cubic meter water storage standpipe, booster pumping station and rechlorination facility was constructed in 2009. With the standpipe, high lift pumps and pressurized cushion tanks this facility maintains pressure in the pressurized zone of the distribution system servicing the Airport and Carmichael Drive areas. The overall system consists of pressure zones 4 and 5 which accommodate a total of nine pumps, including three booster pumps (2 duty and 1 standby) for Zone 4, four booster pumps (3 duty and 1 standby) and two fire pumps for Zone 5. The water standpipe is connected to the zone 4 distribution header to provide zone 4 fire flow and peak hour demand. It is also connect to the zone 5 fire pumps suction header to provide zone 5 fire demand. Zone 5 is equipped with four (4) pneumatic tanks connected to the Zone 5 discharge header to mitigate minor pressure fluctuations within the distribution system, and to provide some volume of available storage during power interruptions before the standby power system engages. This will mitigate the potential for negative pressure in the distribution system.

The North Bay Water Treatment Plant (WTP) has the design capacity of 79,500 cubic meters of water per day. The WTP is a SCADA controlled membrane filtration system with ultraviolet and chlorine disinfection systems. The plant also includes fluoride addition along with caustic pH adjustment prior to delivery to the distribution. The WTP meets the Ontario Drinking Water Standards requirements for the removal/disinfection of 2-log Cryptosporidium oocysts, 3-log Giardia cysts, and 4-log Viruses.

The North Bay WTP achieves the above performance criteria using membrane filtration (0.1 micron pore size), ultraviolet (UV) inactivation and chlorine disinfection.

The filtration process meets the criteria listed in the Procedure for Disinfection of Drinking Water in Ontario for membrane filtration, including;

- 1. Maintain effective backwash procedures, including filter-to-waste or an equivalent procedure, to ensure that the effluent turbidity requirements are met at all times;
- Monitor integrity of the membrane by continuous particle counting or equivalent effective means (e.g., intermittent pressure decay measurements) (Note: intermittent pressure decay monitored at the North Bay WTP).
- 3. Continuously monitor filtrate turbidity; and,
- 4. Meet the performance criterion for filtered water turbidity of less than or equal to 0.1 NTU in 99% of the measurements each month.

The following is a breakdown of the pathogen removal credits for the North Bay WTP:

- Membrane filtration provides 3.0 log removal of Giardia, 2-log removal of Cryptosporidium
- UV inactivation provides 0.5-log removal of Giardia and 0.5-log removal of Cryptosporidium
- Chlorine disinfection provides 4-log removal of viruses

All of the filter rack effluent lines are equipped with continuously monitored, recorded and alarmed turbidity analyzers which will shut down the respective rack if a reading exceeds 0.1 NTU.

Filtered water is directed through the UV disinfection units prior to entering the contact chambers. The two chlorine contact tanks can be operated separately or in sequence and still provide the required 4 log disinfection. This facility is equipped with continuously monitored, recorded and alarmed CT calculation. The SCADA system also automatically takes data from several sources (flow, temperature, free chlorine residual, pH, water depth in contact tanks, and which contact tank is in service) and calculates the log removal credits achieved for Giardia & Viruses.

The following information presents the Annual Record of Water Taking for the North Bay Water Treatment Plant and the treated water consumption.

#### **Raw Water Taking**

In overview some 12,713,539 cubic meters of water were taken from Trout Lake during the year of 2011. The average water taking for 2011 was 34,925 cubic meters per day. The maximum water taking

per day was 51,870 cubic meters in July and this was 65% of the maximum 79,500 cubic meters per day allowed under the Permit to Take Water.

This project provides for the establishment of a corrosion protection program intended to reduce the number of watermain failures on the City's metallic watermains. The project entails installation of sacrificial anodes on approximately 3,200 metres of watermains at determined intervals that will create a corrosion protection system able to withstand a corrosive soil environment.

The tender was publicly advertised in accordance with the City of North Bay Purchasing Policy. Eleven (11) tender packages were distributed directly to contractors. Tenders closed on October 26, 2011. Four (4) responses were received and evaluated by the Manager of Purchasing, Infrastructure Engineer, and Engineering. The results are as follows:

## RECOMMENDATION

#### BACKGROUND

This project provides for the completion of the extension of a primary trunk sewer along Lakeshore Drive and Pinewood Park Drive to service the south end of the City.

In this current 2012 Capital Budget project 3304SS has \$866,667 as a net debenture cost. We were unsuccessful in our request for funding from the Provincial and Federal Governments. Therefore we have shortfall of \$1,633,333. We have also been unsuccessful in our funding requests for the Cedar Height Standpipe project #2803WS. We plan to resubmit our funding requests for both projects. Currently the suggested project to move forward with in 2012 is project #3304SS the Sanitary Sewer Extension to Pinewood Park Drive. To initiate this project \$1,633,333 needs to be transferred from project #2803WS to project #3304SS.

A schedule of the proposed by-law is submitted for Council's consideration.

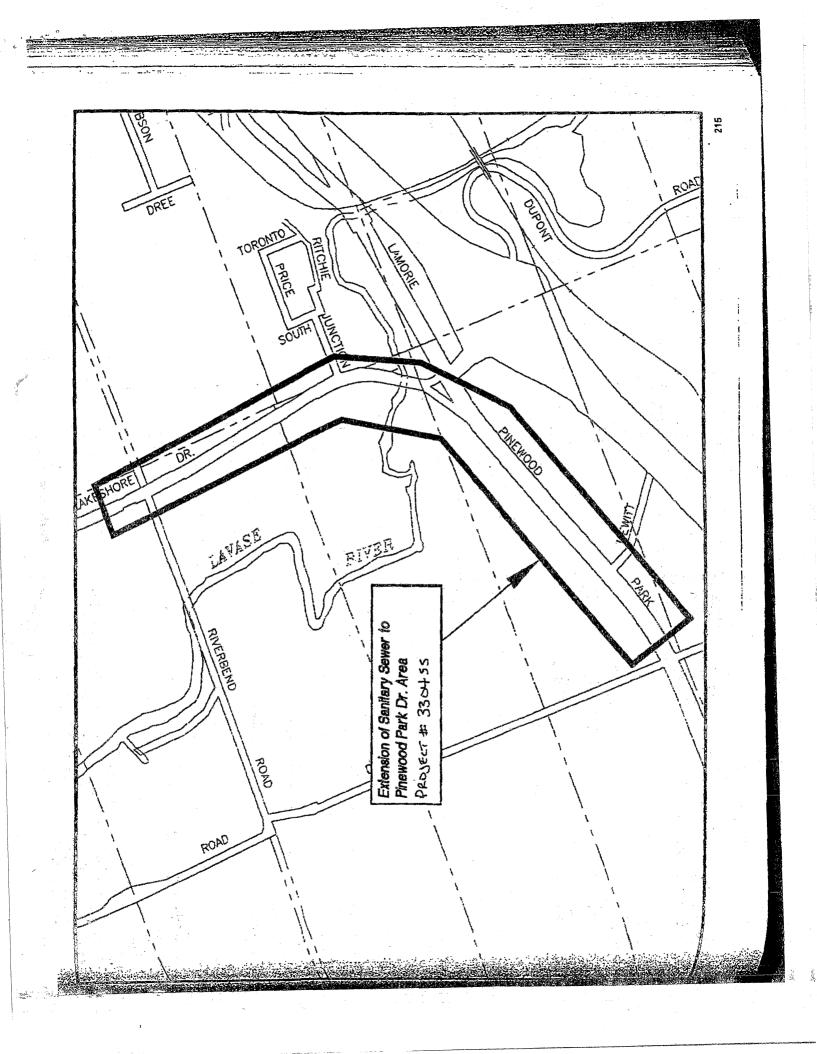

#### RECOMMENDATION

That a Capital Expenditure By-law be prepared for the consideration of City Council to authorize the improvements to the North Bay Jack Garland Airport, being Community Services 2012 Capital Budget Project No.6080AT, at a net debenture cost of \$300,000.

## BACKGROUND

The 2012 Approved Capital Budget includes an amount of \$300,000 for the improvements to the North Bay Jack Garland Airport which includes two projects that are expected to receive funding totally \$508,250 or 95 percent of eligible costs under Transport Canada's ACAP program. The City's 5 percent contribution to these projects total \$26,750. The two ACAP funded projects are the installation of Omni Directional Approach Light System (ODALS) on Runway 26, \$110,000, and the replacement of the RPM Tech 5000 Snow Blower; \$425,000. In the event a portion of the ACAP funding is approved, only those components approved will proceed.

In addition, other projects include the replacement of a 1988 Michigan Loader, brush removal, roof repairs to Terminal & Administration Building, emergency repairs and financing costs. Attached, is a summary of the Airport's anticipated 10 Year Capital Plan.

A Schedule to the proposed By-law is submitted for consideration of Council:

### OPTIONS

### OPTION 1:

That a Capital Expenditure By-law be prepared for the consideration of City Council to authorize the improvements to the North Bay Jack Garland Airport, being Community Services 2012 Capital Project No.6080AT, at a net debenture cost of \$300,000.

This will allow for the continued investment in ongoing capital requirements for the upkeep of the North Bay Jack Garland Airport as well as facilitate the leveraging of up to \$508,250 under Transport Canada's ACAP program.

OPTION 2:

Souncil may cancel this program or reduce the expenditure limit.

Under this option the Airport Corporation would be unable to proceed with ongoing maintenance of the infrastructure and over a period of time, Council would be faced with greater requests for capital assistance. Eliminating or reducing the capital investment in the Airport could also limit the amount of leveraged funds received under the ACAP funding program.

#### RECOMMENDED OPTION

### OPTION 1:

That a Capital Expenditure By-law be prepared for the consideration of City Council to authorize the improvements to the North Bay Jack Garland Airport, being Community Services 2012 Capital Project No. 6080AT, at a net debenture cost of \$300,000.

## RECOMMENDATION

That Council authorize the expenditure of \$138,785.00 (HST extra) to McQuay International for upgrades to the compressor at North Bay City Hall.

#### BACKGROUND

The 2012 Capital Budget includes \$145,476.00 for City Hall rehabilitation. This City Hall Rehabilitation Project (on-going) was authorized by Resolution No. 2012-35 passed by Council at its Regular Meeting held on the 23<sup>rd</sup> day of January, 2012.

In addition to the 2012 capital funds, there are currently unspent 2010/2011 capital funds available in the amount of \$93,024.00.

The life of the existing McQuay chiller is 15 years and we are approaching the end of its life cycle. In order to ensure proper air handling, we have received a quote from McQuay International in the amount of \$138,785.00 (HST extra) for the reconditioning and modernization (i.e. energy efficient) of the existing McQuay centrifugal chiller. As part of the upgrades the existing centrifugal compressor and chiller controller will be replaced with a frictionless, magnetic bearing compressor which is estimated to be 35% to 45% more efficient KW per ton. The need for continued oil samples, oil filters and oil system maintenance will be eliminated for the remaining life of the chiller, thereby saving maintenance costs.

The City has investigated the option of having the upgrades completed by a company other than McQuay International, the original equipment manufacturer. Other companies have declined to provide an estimated for the upgrades. Based on the nature of the equipment, the ongoing service agreement and the outstanding warranties that remain, it was determined that this option is not viable or in the best interest of the City.

Council has the option of upgrading the existing equipment with the original equipment manufacturer or tendering for a new unit. The costs to tender would include costs for engineering consulting services, as well as for the supply and installation of a new unit. The estimated cost for a replacement chiller would be in excess of \$300,000.00 plus taxes.

In accordance with the Purchasing By-law, and based on the information gathered, the Manager of Purchasing has discretion and supports this recommendation to single source the equipment upgrades.

The intent would be to have the upgrades completed immediately as to the chiller needs to be operational to ensure proper air conditioning for the building.

## **OPTIONS ANALYSIS**

- <u>Option # 1</u>: To authorize the compressor upgrades. This is the recommended option.
- <u>Option # 2</u>: Not to authorize the compressor upgrades. This is not recommended as it would compromise the safe use of the building and increase the deterioration of the building's infrastructure.
- Option # 3: To direct staff to complete a tender process for a new unit.

## **RECOMMENDED OPTION**

That Council authorize the expenditure of \$138,785.00 (HST extra) to McQuay International for upgrades to the compressor at North Bay City Hall.
