BY-LAW NO. 61-79

BEING A BY-LAW TO CLOSE TEMPORARILY CERTAIN STREETS TO VEHICULAR TRAFFIC

WHEREAS the Municipal Act, R.S.O. 1970, Chapter 284 S. 4 (1) P. 107 provides for the regulation of traffic on highways.

AND WHEREAS the Municipal Act, R.S.O. 1970, Chapter 284 S. P. 61, as amended, provides for the temporary closing of any highway.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

In this By-law

1.

"Vehicle" includes a motor vehicle, trailer, traction engine, farm tractor, road-building machine and any vehicle drawn, propelled or driven by any kind of power, including muscular power, but does not include a motorized snow vehicle, the cars of electric or steam railways running only upon rails.

- 2. Subject to Section 5, no person shall park a vehicle to be situate on the highways or portions thereof as set out on Schedule "A" attached hereto, at any time during the hours of 12:01 a.m., May 20, 1979 to 9:00 p.m., May 21, 1979.
- 3. Subject to Section 5, the highways or portions thereof as set out on Schedule "A" attached hereto shall be closed to vehicular traffic during the hours of 400 a.m., May 21, 1979 to 9:00 p.m., May 21, 1979.
- 4. Subject to Section 5, no person shall permit or cause to permit any vehicle to be driven on those streets or portions thereof as set out on Schedule "A" attached hereto and forming part of this by-law during the hours of 4:00 a.m., May 21, 1979 to 9:00 p.m., May 21, 1979.
 - The provisions of Section 4 shall not apply to
 - (a) ambulances, police or fire department vehicles, or public utility emergency vehicles or any other vehicle required in the case of an emergency, or
 - (b) vehicles actually engaged in works undertaken for or on behalf of The Corporation of the City of North Bay, or
 - (c) vehicles operated for or on behalf of the Sunnydale Karting Association where an acknowledgement of sole responsibility and indemnification together with a certified copy of a valid policy of public liability insurance showing coverage of at least two million dollars is first provided to the Clerk of the Corporation of the City of North Bay during regular business hours.

Any person violating the provisions of Section 2 or 4 shall be guilty of an offence and subject to a penalty of not more than \$300.00 exclusive of costs to be collected pursuant to the provisions of the Summary Convictions Act.

READ A FIRST TIME IN OPEN COUNCIL THIS 26TH DAY OF MARCH, 1979. READ A SECOND TIME IN OPEN COUNCIL THIS 9TH DAY OF APRIL 1979. READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS 9TH DAY OF APRIL 1979.
