**BEING A BY-LAW TO AMEND BY-LAW NO. 2001-71
BEING A BY-LAW TO AUTHORIZE CHANGES TO
USER FEE SCHEDULES FOR THE VARIOUS
DEPARTMENTS AT CITY HALL
(SCHEDULE "I"- FINANCIAL SERVICES DEPARTMENT)**

WHEREAS Section 391 of the *Municipal Act, 2001* (S.O. 2001, C.25) authorizes the Council to pass by-laws imposing fees or charges for services or activities provided or done by or on behalf of the municipality and for the use of its property;

AND WHEREAS Council passed Resolution No. 2004-196 at its meeting held March 22, 2004 to approve the amendments to the Financial Services Department's Fee Schedule;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Schedule "I" to User Fee By-law No. 2001-71 be hereby deleted from the by-law and the Schedule "I" attached hereto and part of this by-law be inserted in lieu thereof.
2. That this by-law take effect upon being passed.
