

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 14-68

BEING A BY-LAW TO FURTHER AMEND BY-LAW NO. 2004 OF THE CORPORATION OF THE CITY OF NORTH BAY, AS AMENDED BY BY-LAW NOS. 2184 AND 2378, OF THE CORPORATION OF THE CITY OF NORTH BAY, AUTHORIZING THE CONSTRUCTION AND EQUIPPING OF AN ADDITION TO THE NORTH BAY CIVIC HOSPITAL

WHEREAS the estimated cost of renovations to the Fifth Floor of the East Wing of the North Bay Civic Hospital, in accordance with the latest plans, as approved by the North Bay Hospital Commission and the Ontario Hospital Services Commission, amounts to the sum of \$318,000.00;-

AND WHEREAS it is necessary to complete the aforesaid work at the aforesaid cost, and to borrow on the credit of The Corporation the sum of \$106,000.00, being the net cost to The Corporation after deducting Federal and Provincial Grants;-


NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:-

1. THAT the aforesaid work be proceeded with at the earliest possible date at an estimated cost of \$318,000.00, and that an additional sum of \$106,000.00 be borrowed on the credit of The Corporation of the City of North Bay to pay for the Corporation's share or cost of the aforesaid work.
2. THAT By-law No. 2004, aforesaid, as amended by By-laws Nos. 2184 and 2378, be further amended in accordance with this By-law.
3. THIS BY-LAW shall take effect upon the final passing thereof, subject to receiving the approval of the Ontario Municipal Board.

READ A FIRST TIME IN OPEN COUNCIL THIS 12TH DAY OF FEBRUARY, 1968.

READ A SECOND TIME IN OPEN COUNCIL THIS 22th DAY OF FEBRUARY, 1968.

READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS 26TH DAY OF FEBRUARY, 1968.

to the North Bay Civic Hospital approved by a previous order
of the Board made on the 13th day of June, 1962, and entered
in order book No. E 32 at folio 213 on the 15th day of June,
1962, and for such purpose may pass all requisite by-laws,
provided:



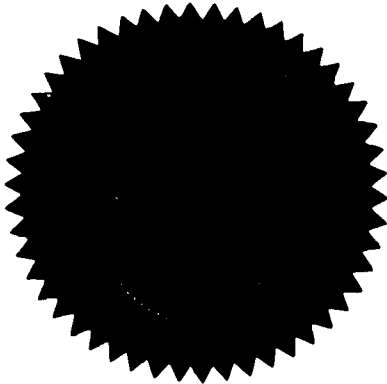

1. that no part of the additional amount of \$318,000 may be debentured, and
2. that the said Corporation may borrow the whole or any part of the said sum of \$318,000 as required pending receipt of subsidies or of moneys to be received from any other source, and
3. that the Corporation in exercising any of its powers approved by this order shall comply with all statutory and other legal requirements related thereto.
