And Whereas the Ontario Federation of Anglers and Hunters (OFAH) has advised that the Annual Spring Black Bear Hunt is a successful wildlife management tool that minimized dangerous encounters between people and black bears;

And Whereas the OFAH has advised that the annual Spring Bear Hunt contributed over \$40 million dollars annually to the Ontario economy – the majority of which was in Northern Ontario;

And Whereas the Council of the City of North Bay supports the Ontario Federation of Anglers and Hunters and hunting opportunities in Northern Ontario;

NOW THEREFORE BE IT RESOLVED that the City of North Bay hereby petitions the Province of Ontario to ensure that the annual Spring Bear Hunt be reinstated permanently and continue during the Province's review of their two year pilot project;

And FURTHER that a copy of this resolution be forwarded to the Honourable Premier Kathleen Wynne, the Honourable Bill Mauro, Minister of Natural Resources and Forestry, the Honourable Michael Gravelle, Minister of Northern Development and Mines, Mr. Victor Fedeli, MPP Nipissing, FONOM, AMO; the leaders of the Provincial Opposition and Nature and Outdoor Tourism Ontario (NOTO).
