BY-LAW NO. 133-90

A BY-LAW TO AMEND BY-LAW 53-79 TO ENFORCE PARKING RESTRICTIONS AT THE COLLEGE EDUCATION CENTRE.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. North Bay By-law 53-79 is hereby amended by adding thereto the following sections:
 - 10. No person shall park or leave any motor vehicle on lands owned by The Board of Governors of Canadore College unless such motor vehicle has been parked within a designated parking space, which is governed by a sign erected by the said College.
 - ll. No person shall park or leave any motor vehicle in a designated parking area on lands owned by The Board of Governors of Canadore College without a valid permit for such parking area issued by the said College.
 - 12. No person shall park or leave any motor vehicle on lands owned by The Board of Governors of Canadore College
 - (a) so as to obstruct the passage of another vehicle;
 - (b) which are designated by signs as a disabled parking space without a valid disabled parking permit;
 - (c) which are designated by signs as a fire route;
 - (d) which are designated by signs as a pedestrian crossing;
 - (e) which are designated by signs as a bus stop;
 - (f) which are designated by signs to prohibit parking;
 - (g) which are designated by signs as a loading zone.
 - 13. (i) No person shall park or leave any motor vehicle on lands owned by The Board of Governors of Canadore College for which entry is through gates unless such motor vehicle has been parked within an individual parking space, and the driver or operator of such motor vehicle has a current ticket issued at the parking gate by Canadore College on display in the front window of such vehicle.
 - (ii) No person shall permit a motor vehicle under his or her control to occupy an individual parking space beyond the period of legal parking time acquired by the said current ticket, and if any motor vehicle shall remain in such individual parking space after the expired time, such vehicle shall be considered as remaining in such individual parking space beyond the said period of legal parking time.

- (iii) No person shall deposit or cause to be deposited in any parking gate, any slug, device, metallic or other substitute for coins.
- 14. Any officer, employed by the said College appointed to enforce this by-law:
 - (a) shall be insured by the College for any liability arising during the course of his employment;
 - (b) shall have participated in and passed the training session of the City Parking Manager on the issuance of Parking Infraction Notices under the Provincial Offences Act;
 - (c) shall have clearance from the North Bay Police force as to good character;
 - (d) appear in Provincial Offences Court as required;
- 15. In this by-law,

"lands owned by The Board of Governors of Canadore College" shall include each parcel of land described on Schedule "B" hereto.
