BY-LAW NO. 2438

A by-law to amend By-law 2054, a By-law to regulate the proceedings of the Council of the Corporation of the City of North Bay, Ontario.

Whereas it is deemed expedient to amend said By-law 2054

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1.

THAT Schedule "A" to By-law Number 2054 be amended as follows:

- (a) That the list of committees set out in Sec. 66(a) be deleted and there be substituted therefor the following:
 - General Government
 - $\binom{1}{2}$ Protection to Persons and Property
 - (3) Public Works
 - (4) Health and Public Welfare
 - (5)Community Services
- (b) That Sec. 66 be amended by adding thereto, immediately following Clause (b)
 - Notwithstanding the provisions of Clauses (b) and (c) hereof, during the term of the Council (bb) elected the 14th day of December A.D. 1967, the Striking Committee shall be composed of the Mayor, the two Aldermen who obtained the largest number of votes in the North Bay Ward at that election and the alderman who obtained the largest number of votes in each of the Widdifield and West Ferris Wards at that election.
- (c) That Sections 76, 77 and 80 be deleted.
- (d) That the functions, powers and duties of The Protection to Persons and Property Committee relating to Waterworks be transferred to the Public Works Committee.
- (e) That the functions, powers and duties of the former Sanitation and Waste Committee be transferred to the Public Works Committee.
- (f) That the functions, powers and duties of the former By-laws and Planning Committee, except those relating to the regulation and control of the Building Inspector be transferred to the General Government Committee.
- (g) That the functions, powers and duties of the Health and Public Welfare Committee relating to ambulance service and the functions, powers and duties of the Traffic and Transportation Committee relating to bus transportation be transferred to the General Government Committee.

- (h) That the functions, powers and duties of the Traffic and Transportation Committee relating to street lighting, animal control and emergency measures be transferred to the Protection to Persons and Property Committee and all functions, powers and duties of the Traffic and Transportation Committee not transferred to the General Government and Protection to Persons and Property Committees be transferred to the Public Works Committee.
- (i) That Sec. 89 be amended by adding thereto the following.
 - (d) Each committee of Council shall be composed of a Chairman, a Vice-Chairman and two other members, the Mayor being <u>ex officio</u> a member of each committee.
 - (e) Each member of council shall be appointed as a Chairman or Vice-Chairman of a Committee, but not both, and shall be appointed to one other committee as a member thereof.
